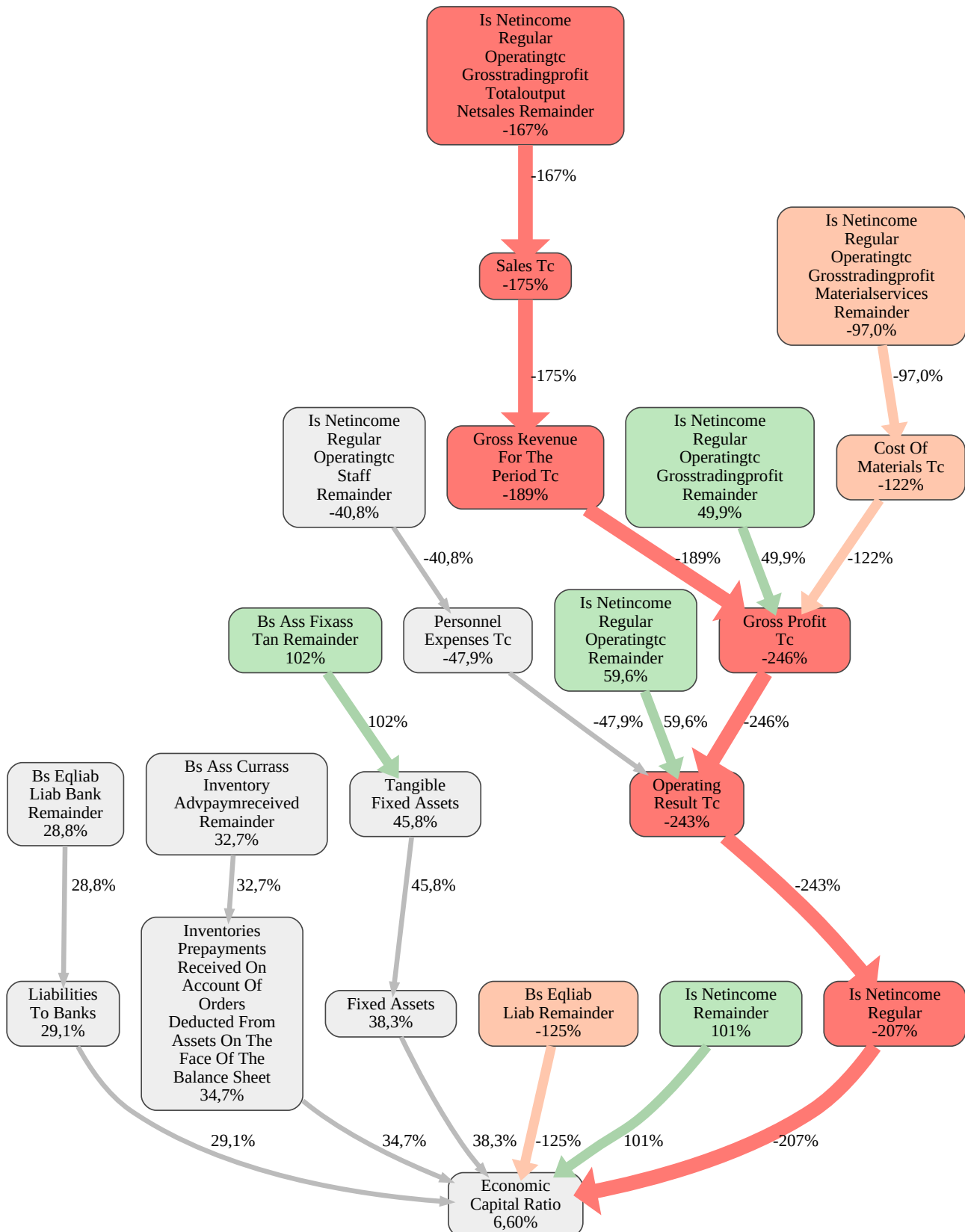

The relative strengths and weaknesses of Wiwog Wittenberger Wohnungsbaugesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wiwog Wittenberger Wohnungsbaugesellschaft mbH compared to the market average is the variable Bs Ass Fixass Tan Remainder, increasing the Economic Capital Ratio by 102% points. The greatest weakness of Wiwog Wittenberger Wohnungsbaugesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 246% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 6,6% points above the market average of 97%.
