



The relative strengths and weaknesses of Hammer Gemeinnützige Baugesellschaft mit Beschränkter Haftung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hammer Gemeinnützige Baugesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 49% points. The greatest weakness of Hammer Gemeinnützige Baugesellschaft mit Beschränkter Haftung is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 49%, being 48% points below the market average of 97%.
