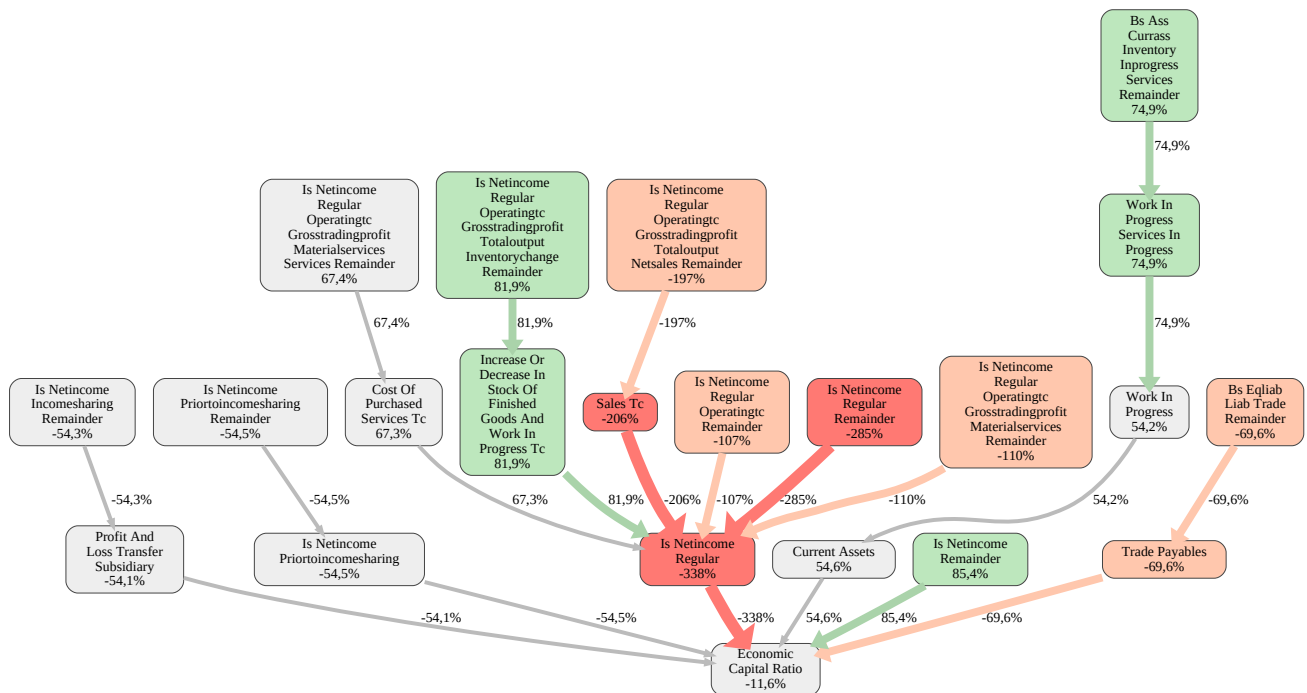




The relative strengths and weaknesses of ZECH Sports GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ZECH Sports GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of ZECH Sports GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 338% points.

The company's Economic Capital Ratio, given in the ranking table, is 85%, being 12% points below the market average of 97%.
