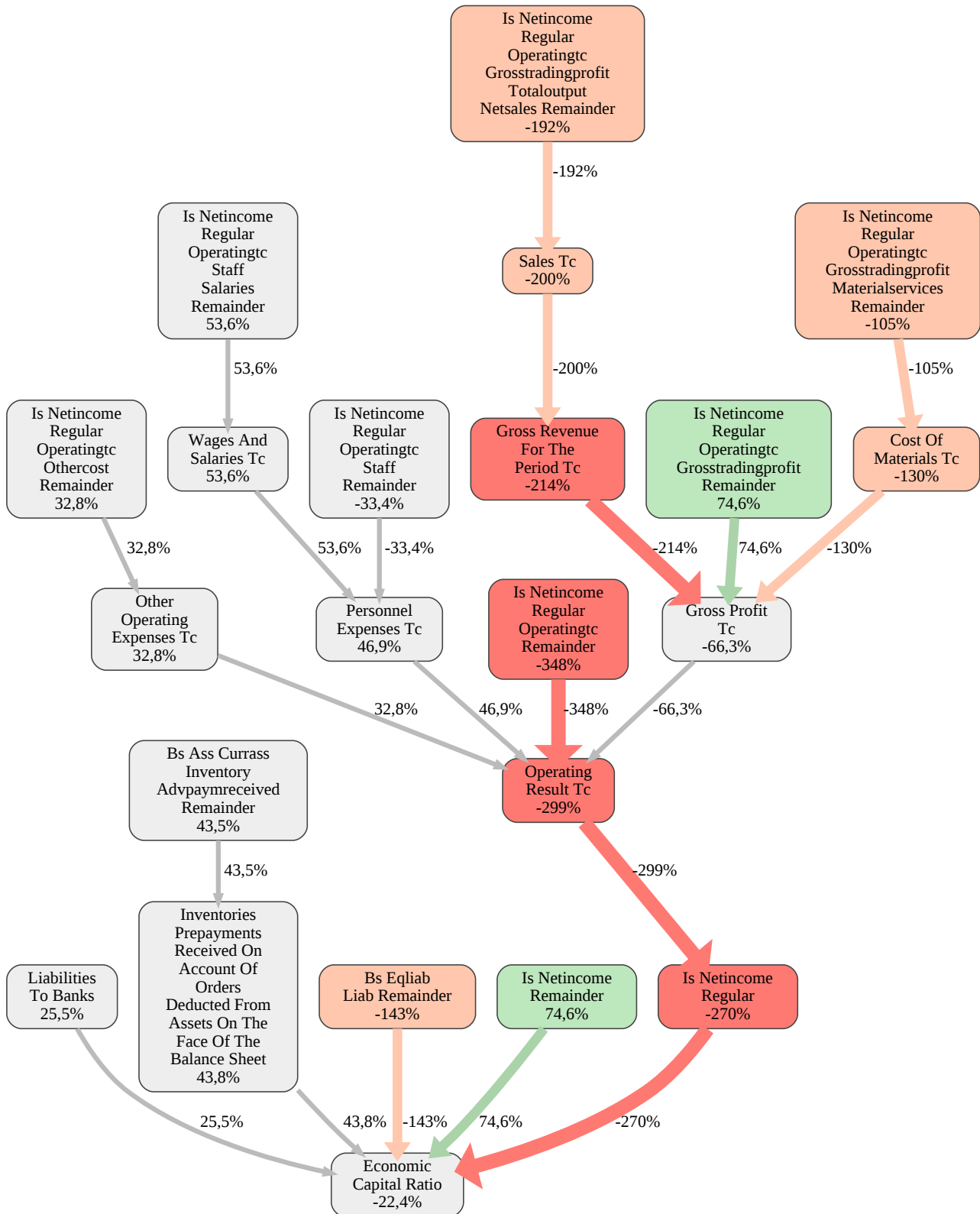




The relative strengths and weaknesses of Concrete Rudolph GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Concrete Rudolph GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Concrete Rudolph GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 348% points.

The company's Economic Capital Ratio, given in the ranking table, is 75%, being 22% points below the market average of 97%.
