The greatest strength of Josef Rädlinger Ingenieurbau GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 162% points. The greatest weakness of Josef Rädlinger Ingenieurbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 747% points.

The company's Economic Capital Ratio, given in the ranking table, is 162%, being 65% points above the market average of 97%.
