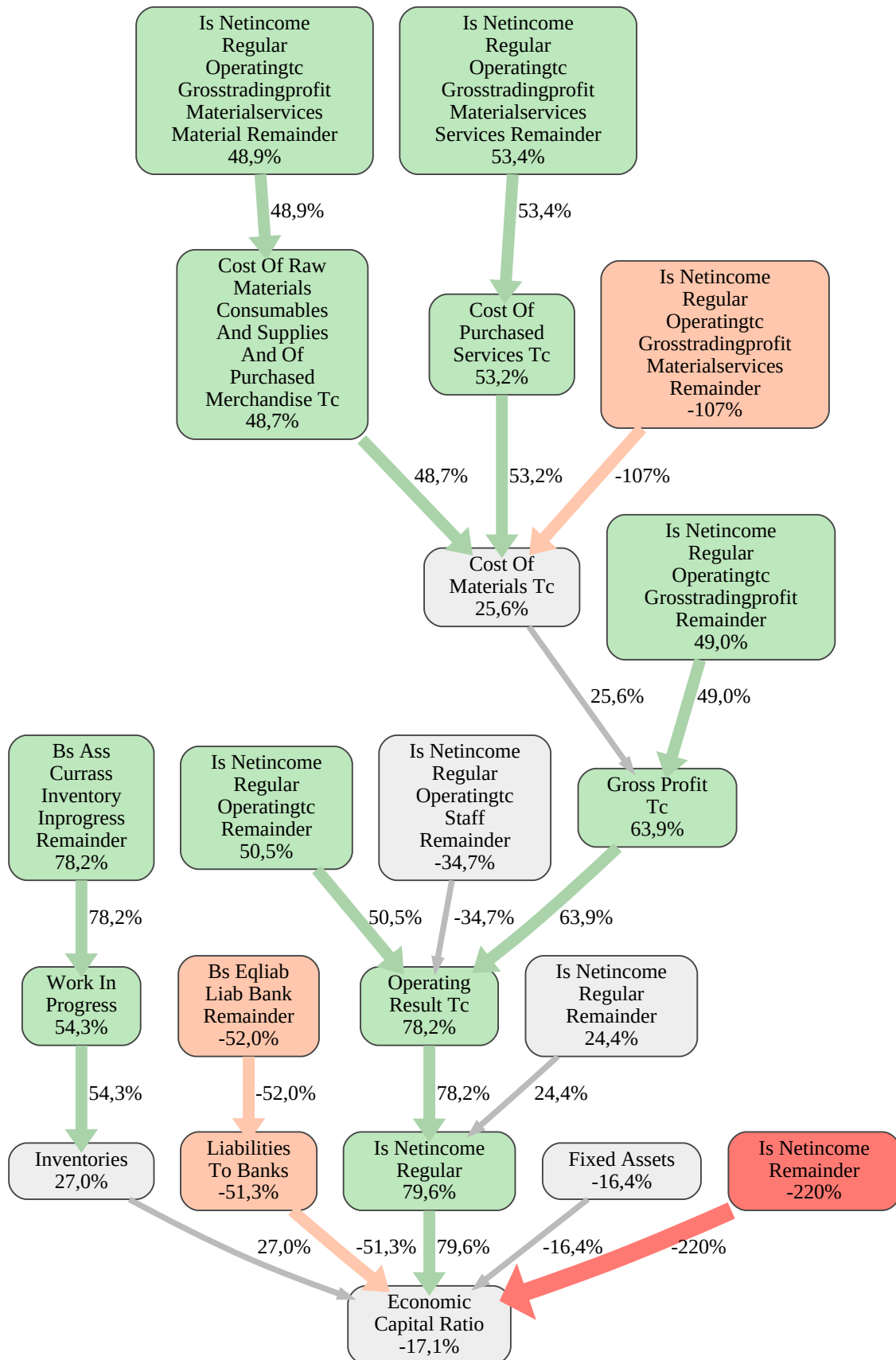




The relative strengths and weaknesses of Arning Bauunternehmung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arning Bauunternehmung GmbH Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Arning Bauunternehmung GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 220% points.

The company's Economic Capital Ratio, given in the ranking table, is 80%, being 17% points below the market average of 97%.
