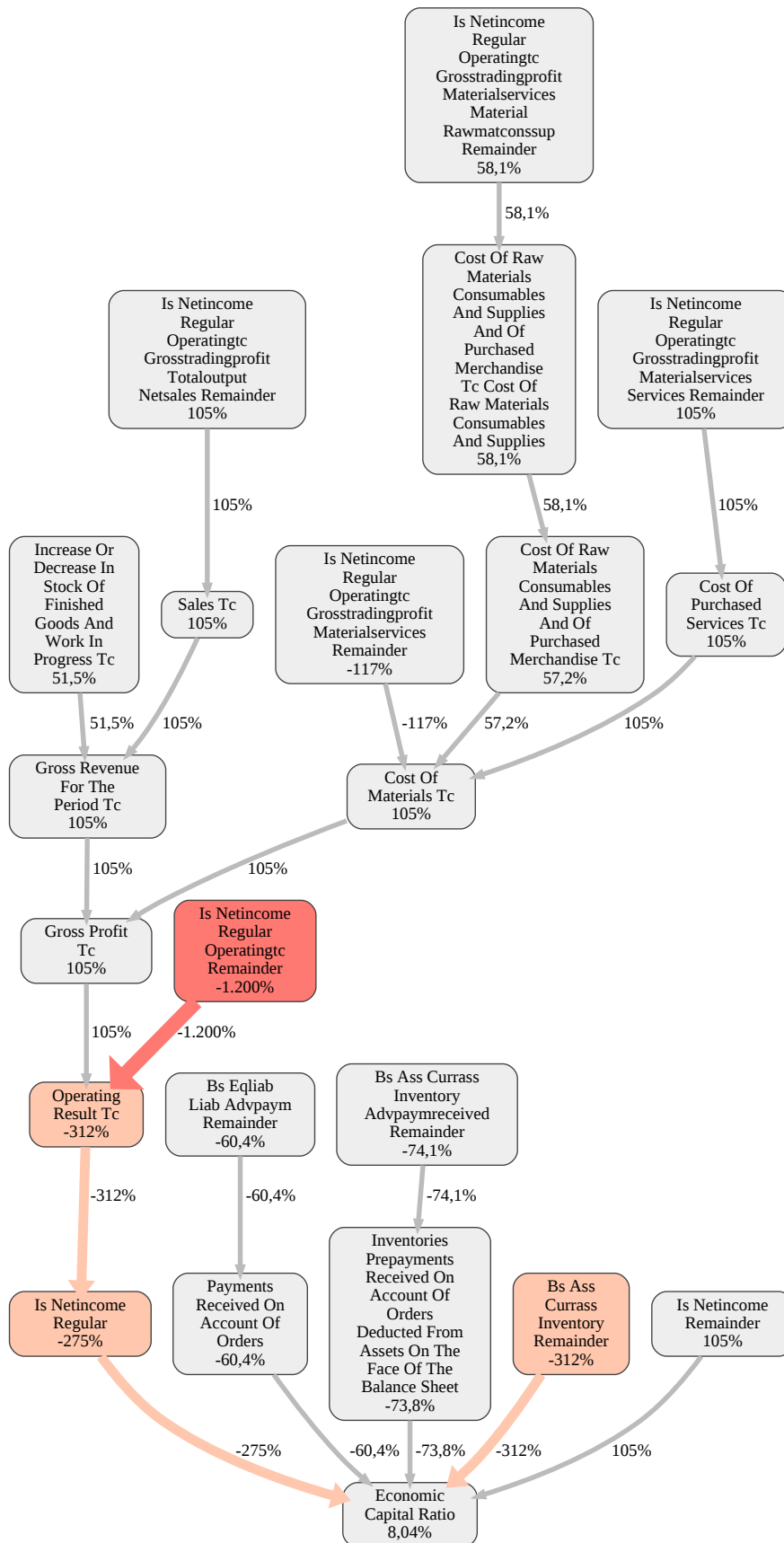




The relative strengths and weaknesses of Homestead GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Homestead GmbH Co KG Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Services Remainder, increasing the Economic Capital Ratio by 105% points. The greatest weakness of Homestead GmbH Co KG Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.200% points.

The company's Economic Capital Ratio, given in the ranking table, is 105%, being 8,0% points above the market average of 97%.
