The greatest strength of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 117% points. The greatest weakness of Joachim Nessler Geschäftsführungsgesellschaft mbh Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 689% points.

The company's Economic Capital Ratio, given in the ranking table, is 117%, being 20% points above the market average of 97%.
