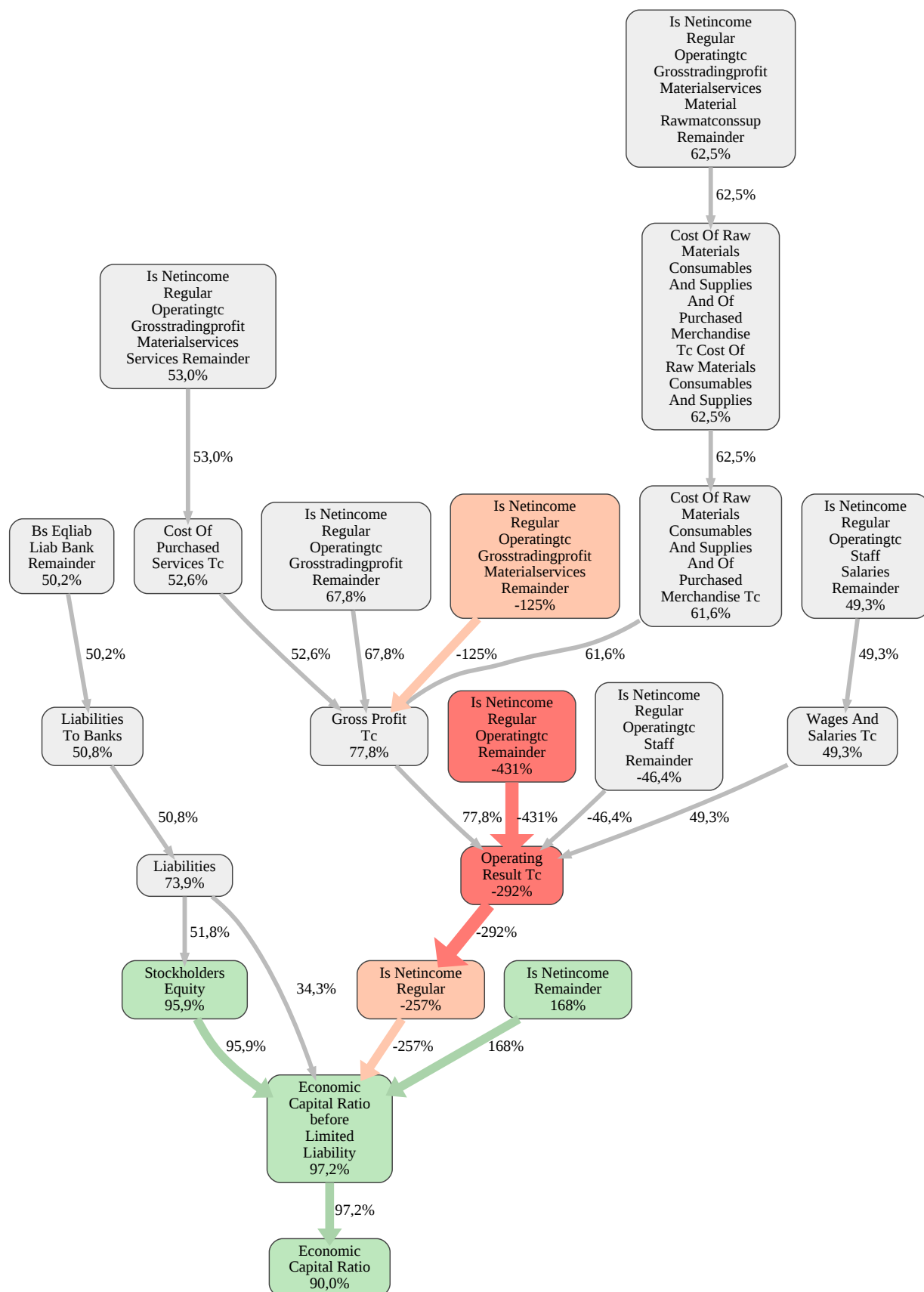




The relative strengths and weaknesses of Lindner Group KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lindner Group KG Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 168% points. The greatest weakness of Lindner Group KG Konzern is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 431% points.

The company's Economic Capital Ratio, given in the ranking table, is 187%, being 90% points above the market average of 97%.
