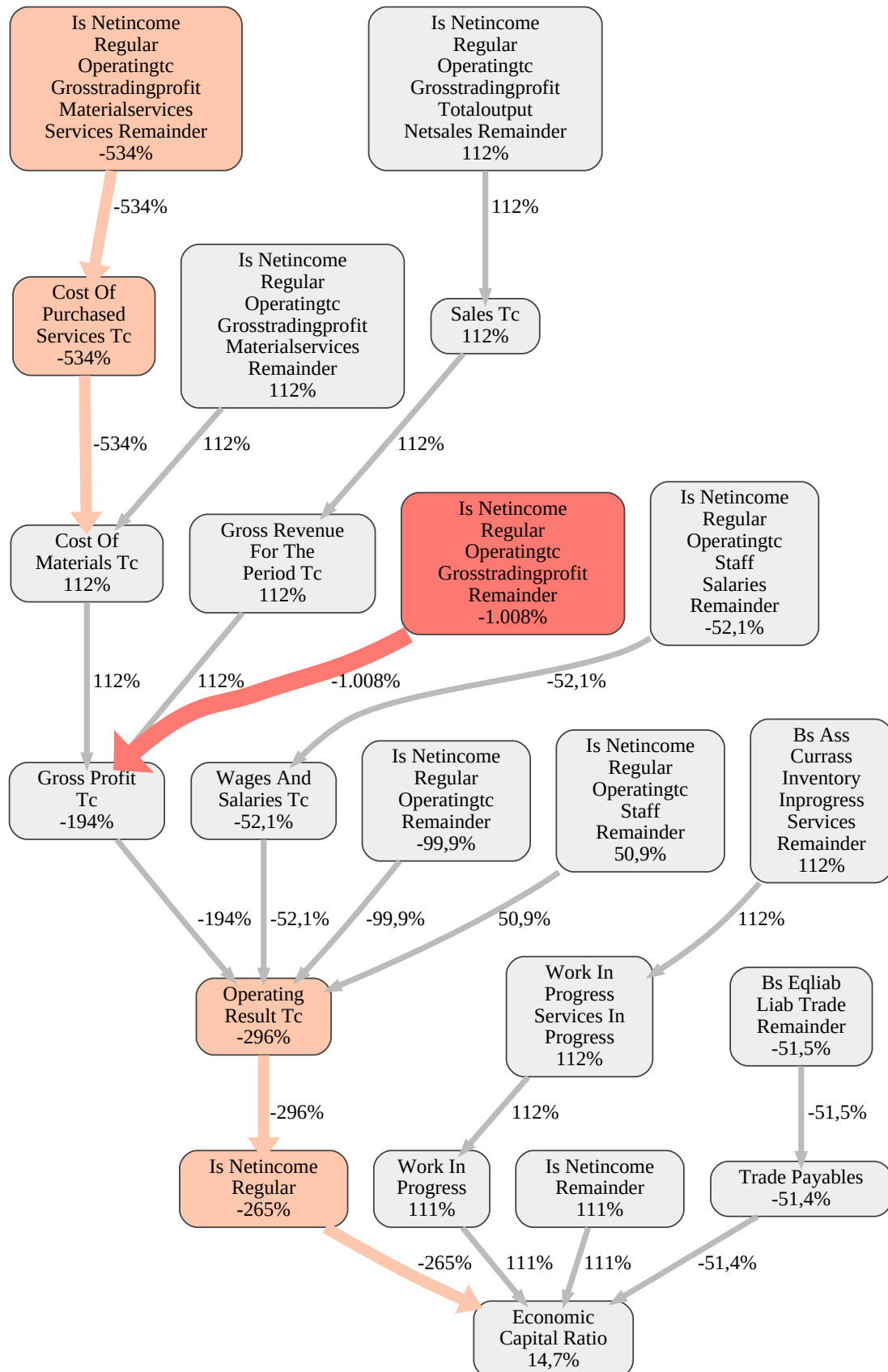




The relative strengths and weaknesses of B O Wohnungswirtschaft GmbH Chemnitz Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of B O Wohnungswirtschaft GmbH Chemnitz Konzern compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 112% points. The greatest weakness of B O Wohnungswirtschaft GmbH Chemnitz Konzern is the variable Is Netincome Regular Operatingtc Grosstradingprofit Remainder, reducing the Economic Capital Ratio by 1.008% points.

The company's Economic Capital Ratio, given in the ranking table, is 112%, being 15% points above the market average of 97%.
