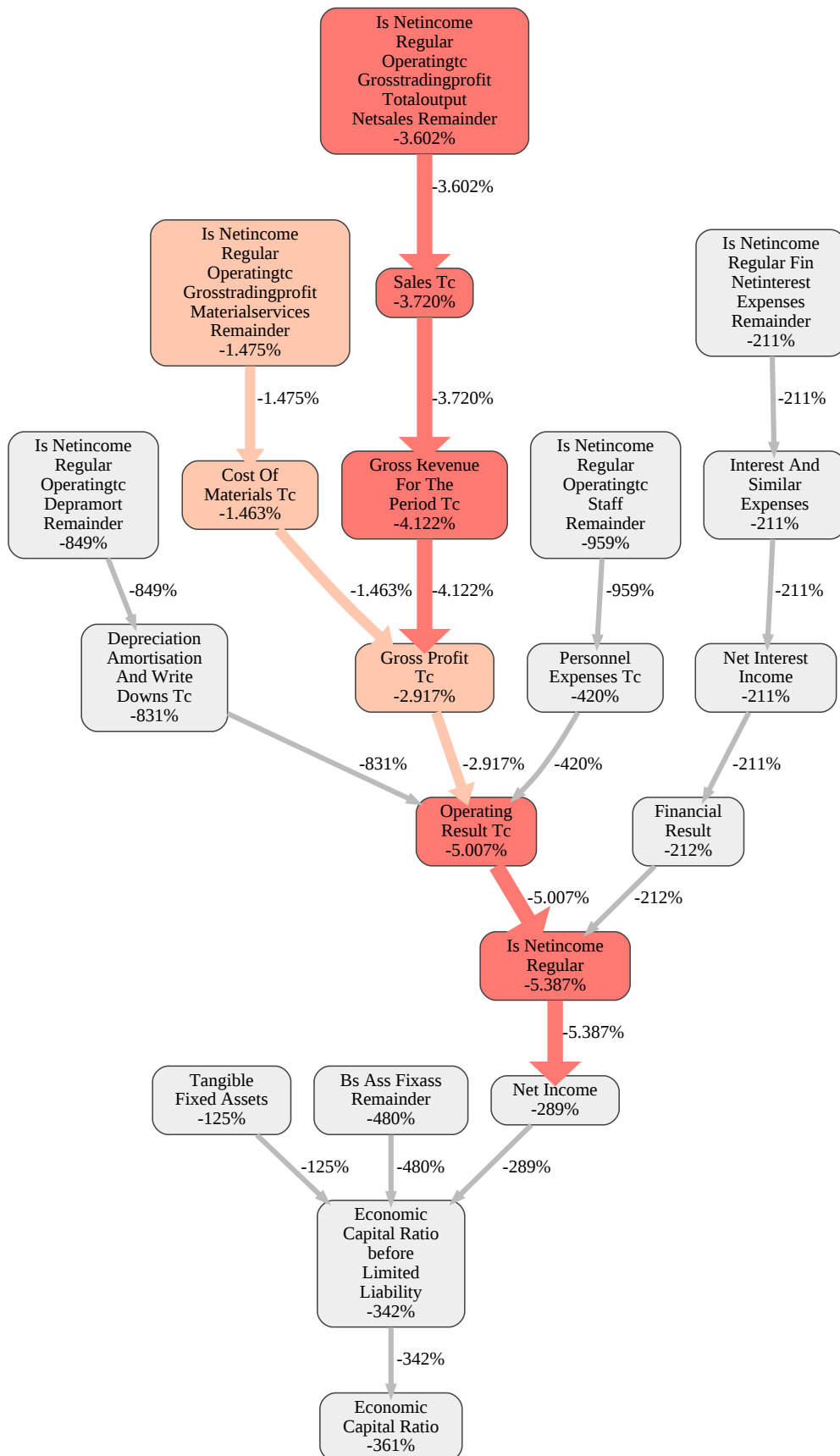




The relative strengths and weaknesses of Wohlfühlhaus Bau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohlfühlhaus Bau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 0,011% points. The greatest weakness of Wohlfühlhaus Bau GmbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.387% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,011%, being 361% points below the market average of 361%.
