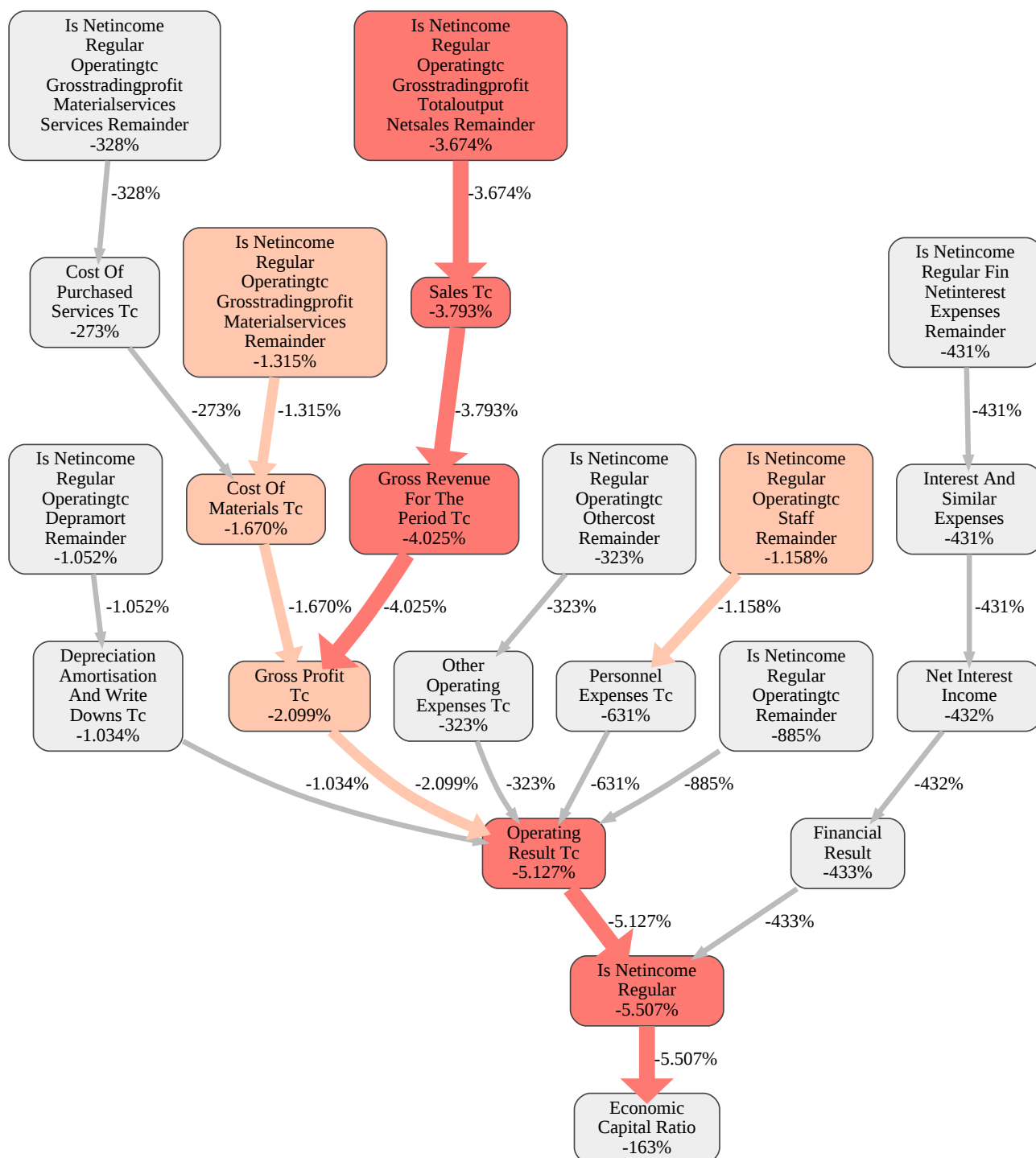






The relative strengths and weaknesses of Unglehrt GmbH Co KG Bauunternehmen are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Unglehrt GmbH Co KG Bauunternehmen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 199% points. The greatest weakness of Unglehrt GmbH Co KG Bauunternehmen is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.507% points.

The company's Economic Capital Ratio, given in the ranking table, is 199%, being 163% points below the market average of 361%.
