

The greatest strength of Mauss Bau GmbH Co KG compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 62% points. The greatest weakness of Mauss Bau GmbH Co KG is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.517% points.

The company's Economic Capital Ratio, given in the ranking table, is 62%, being 299% points below the market average of 361%.
