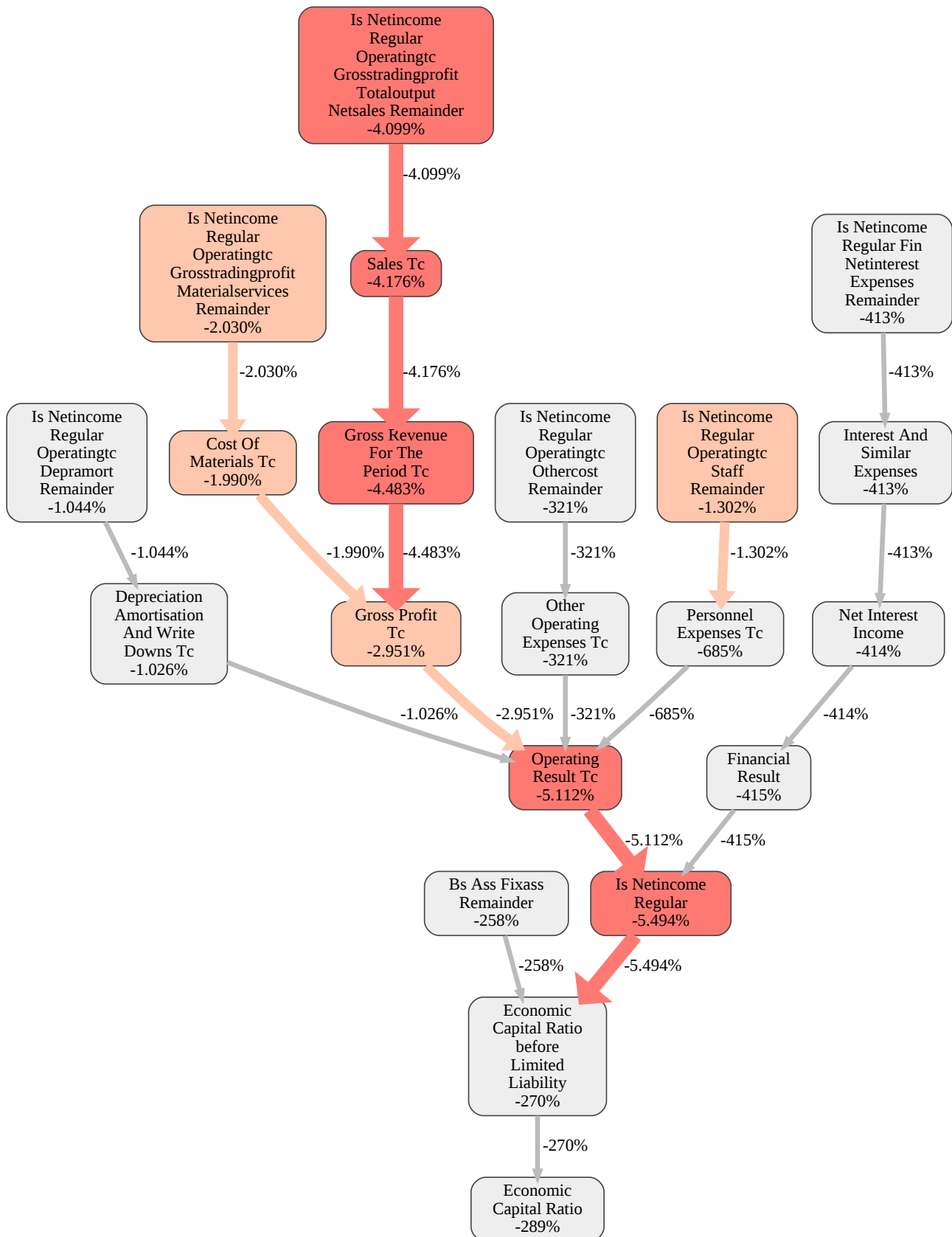




The relative strengths and weaknesses of Hattersheimer Wohnungsbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hattersheimer Wohnungsbau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of Hattersheimer Wohnungsbau GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.494% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 289% points below the market average of 361%.
