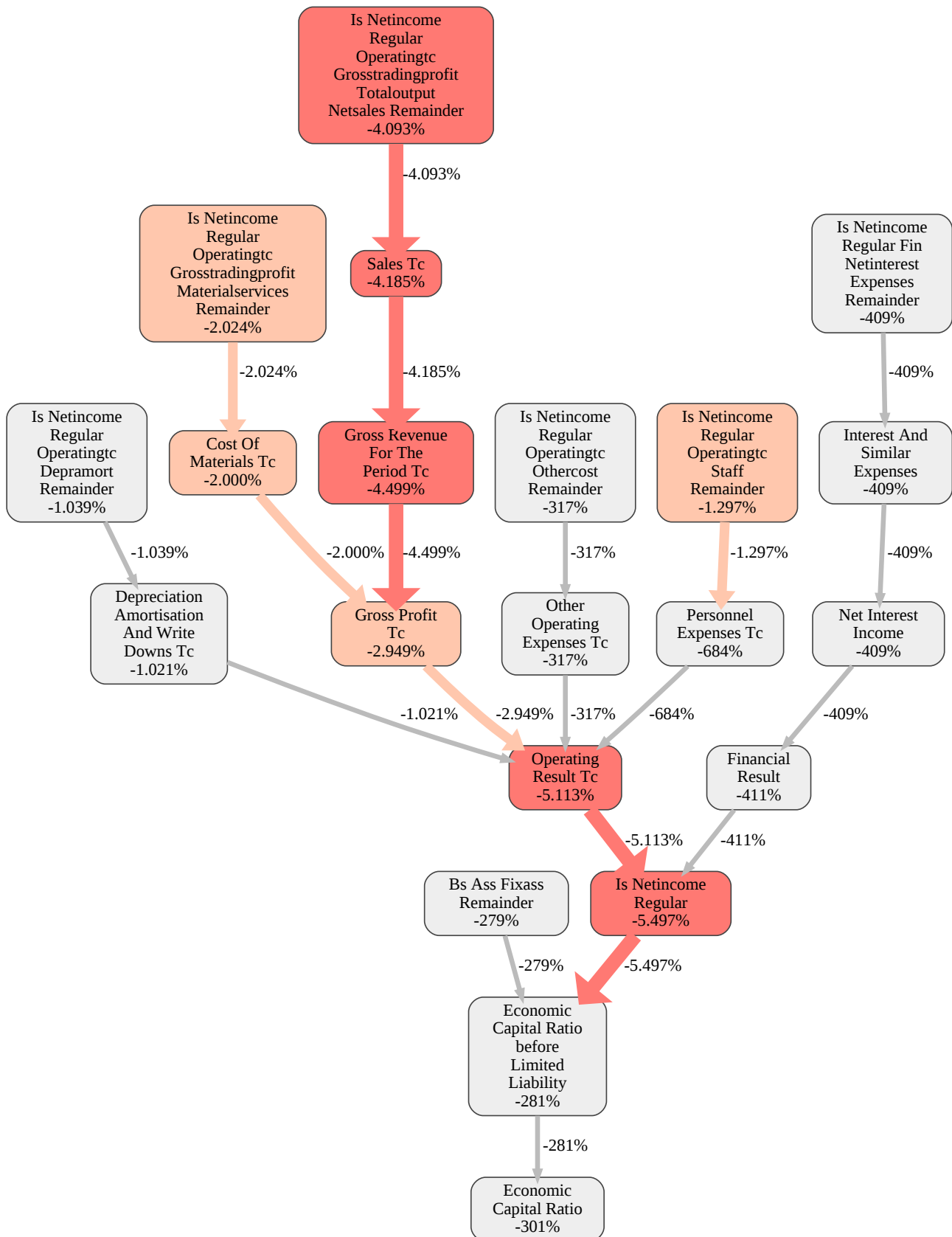




The relative strengths and weaknesses of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 61% points. The greatest weakness of Wobak Städtische Wohnungsbaugesellschaft mbH Konstanz is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.497% points.

The company's Economic Capital Ratio, given in the ranking table, is 61%, being 301% points below the market average of 361%.
