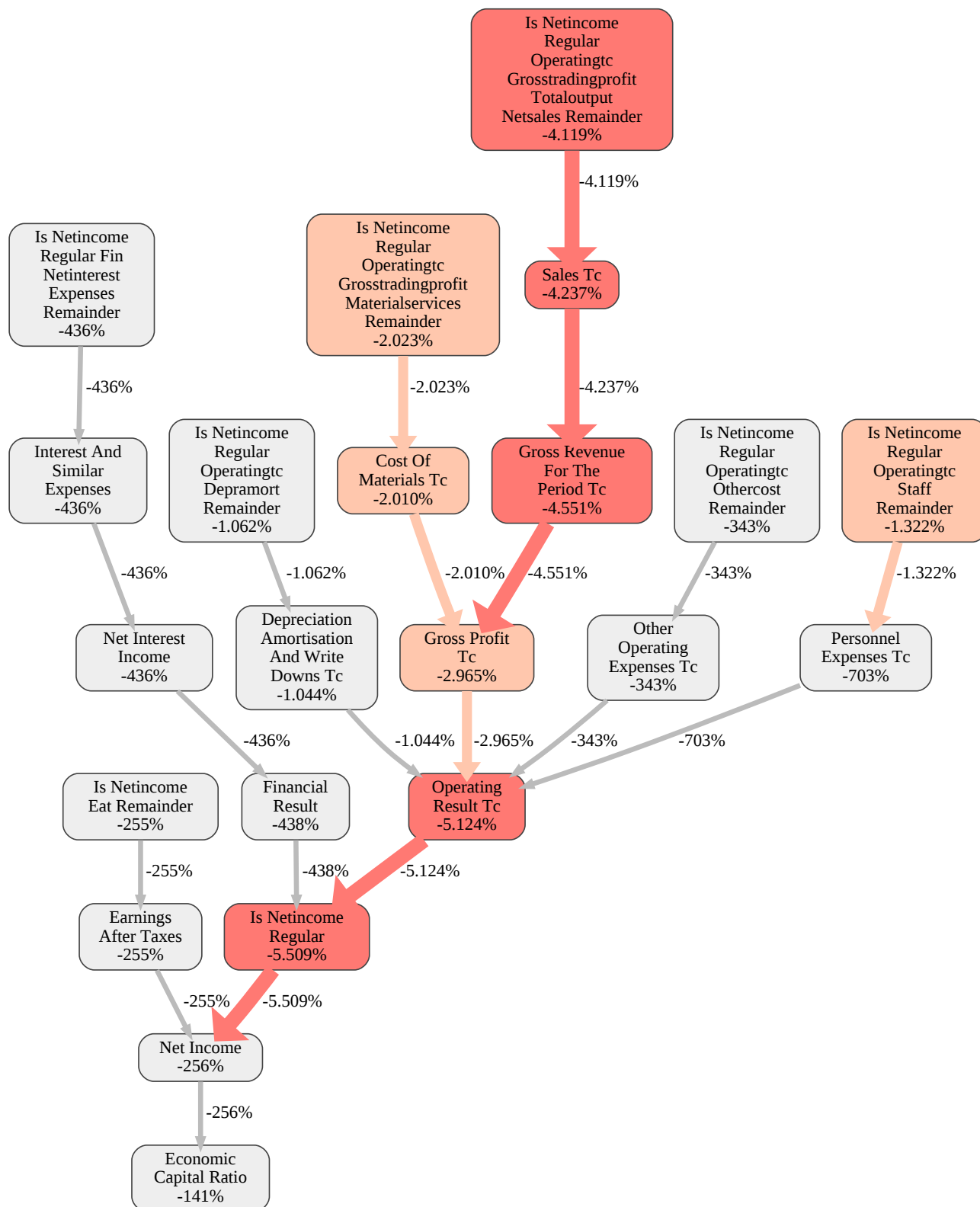




The relative strengths and weaknesses of Wohnbauten GmbH Schwedt Oder are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbauten GmbH Schwedt Oder compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 220% points. The greatest weakness of Wohnbauten GmbH Schwedt Oder is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.509% points.

The company's Economic Capital Ratio, given in the ranking table, is 220%, being 141% points below the market average of 361%.
