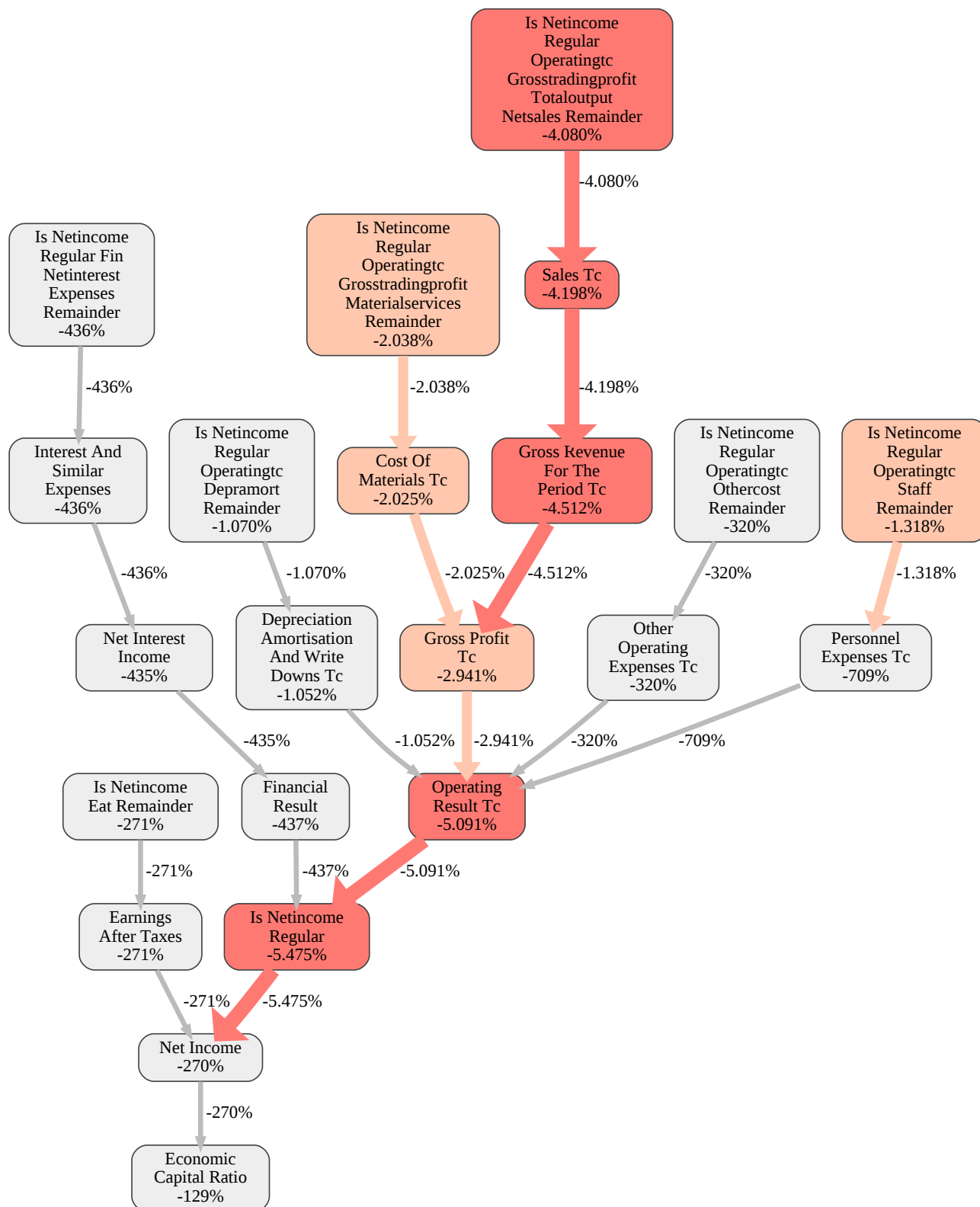




The relative strengths and weaknesses of HS Bauträger GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HS Bauträger GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 232% points. The greatest weakness of HS Bauträger GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.475% points.

The company's Economic Capital Ratio, given in the ranking table, is 232%, being 129% points below the market average of 361%.
