



The relative strengths and weaknesses of Bauunternehmung Glöckle SF Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Glöckle SF Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 167% points. The greatest weakness of Bauunternehmung Glöckle SF Bau GmbH is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.359% points.

The company's Economic Capital Ratio, given in the ranking table, is 167%, being 194% points below the market average of 361%.
