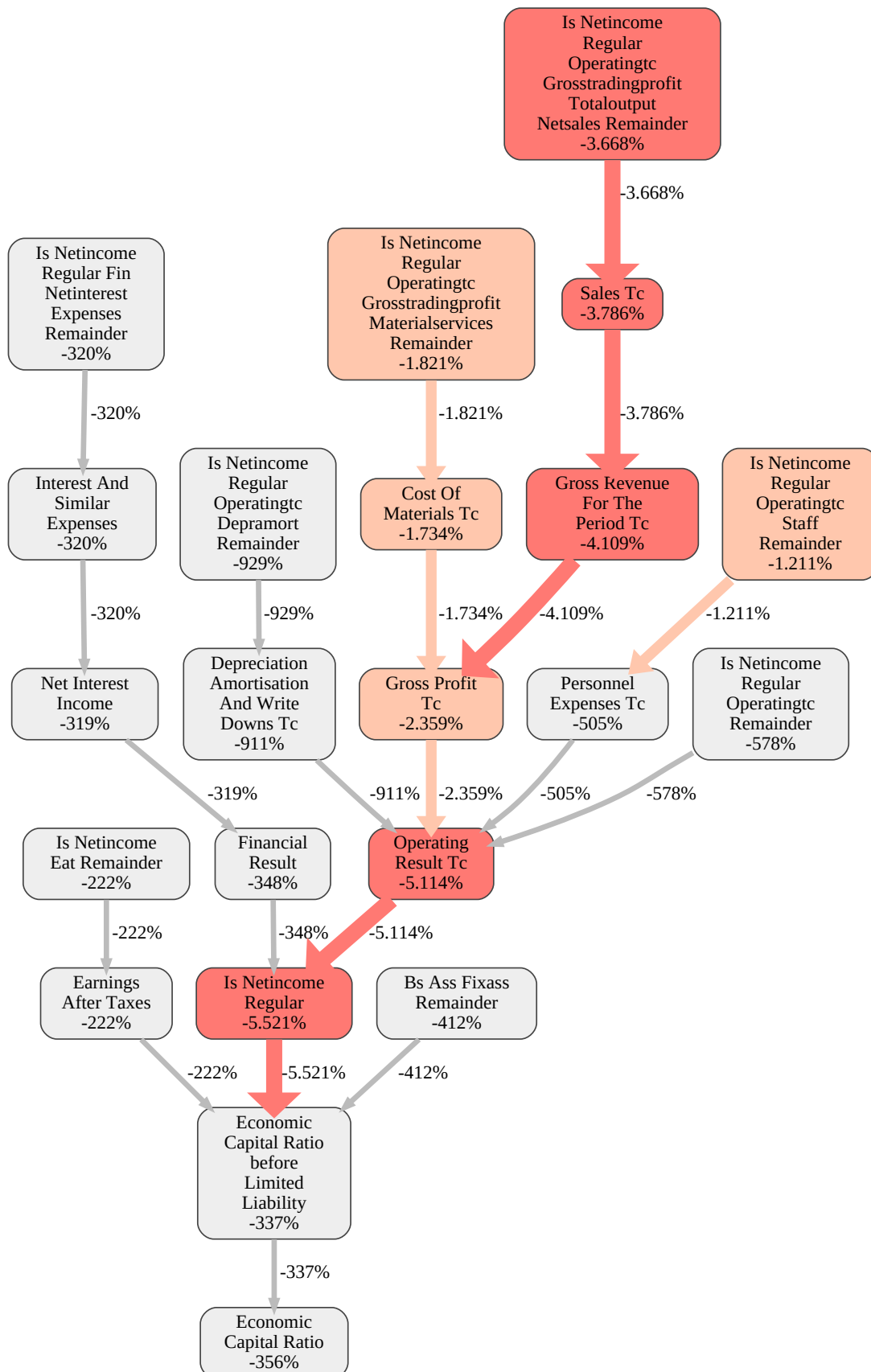




The relative strengths and weaknesses of ELK Fertighaus GmbH Zweigniederlassung Dtl are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ELK Fertighaus GmbH Zweigniederlassung Dtl compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 5,0% points. The greatest weakness of ELK Fertighaus GmbH Zweigniederlassung Dtl is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.521% points.

The company's Economic Capital Ratio, given in the ranking table, is 5,0%, being 356% points below the market average of 361%.
