



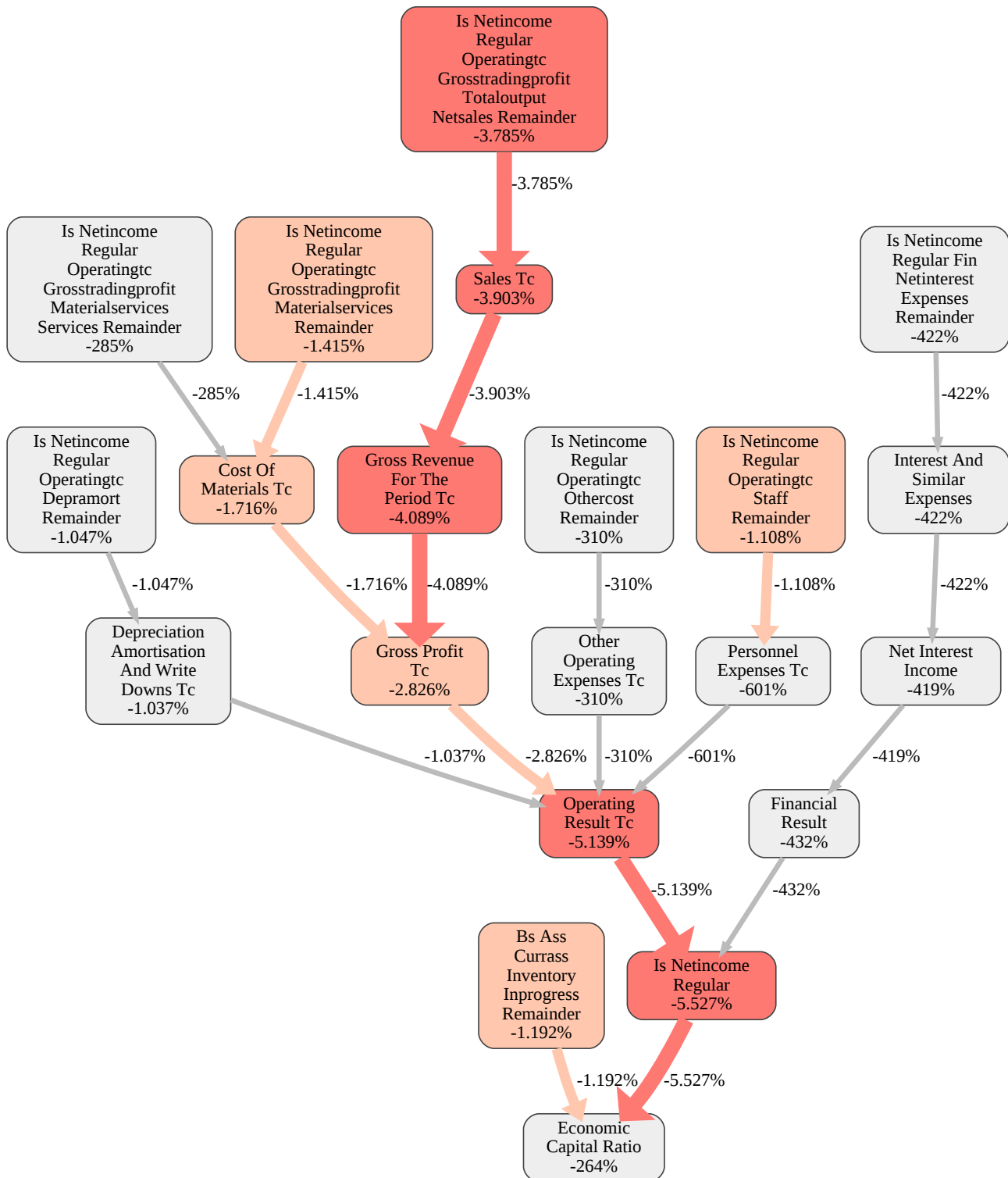

The relative strengths and weaknesses of Echterhoff Holding GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Echterhoff Holding GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Echterhoff Holding GmbH Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.527% points.

The company's Economic Capital Ratio, given in the ranking table, is 97%, being 264% points below the market average of 361%.
