



The relative strengths and weaknesses of Homestead GmbH Co KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Homestead GmbH Co KG Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 104% points. The greatest weakness of Homestead GmbH Co KG Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 5.541% points.

The company's Economic Capital Ratio, given in the ranking table, is 104%, being 258% points below the market average of 361%.
