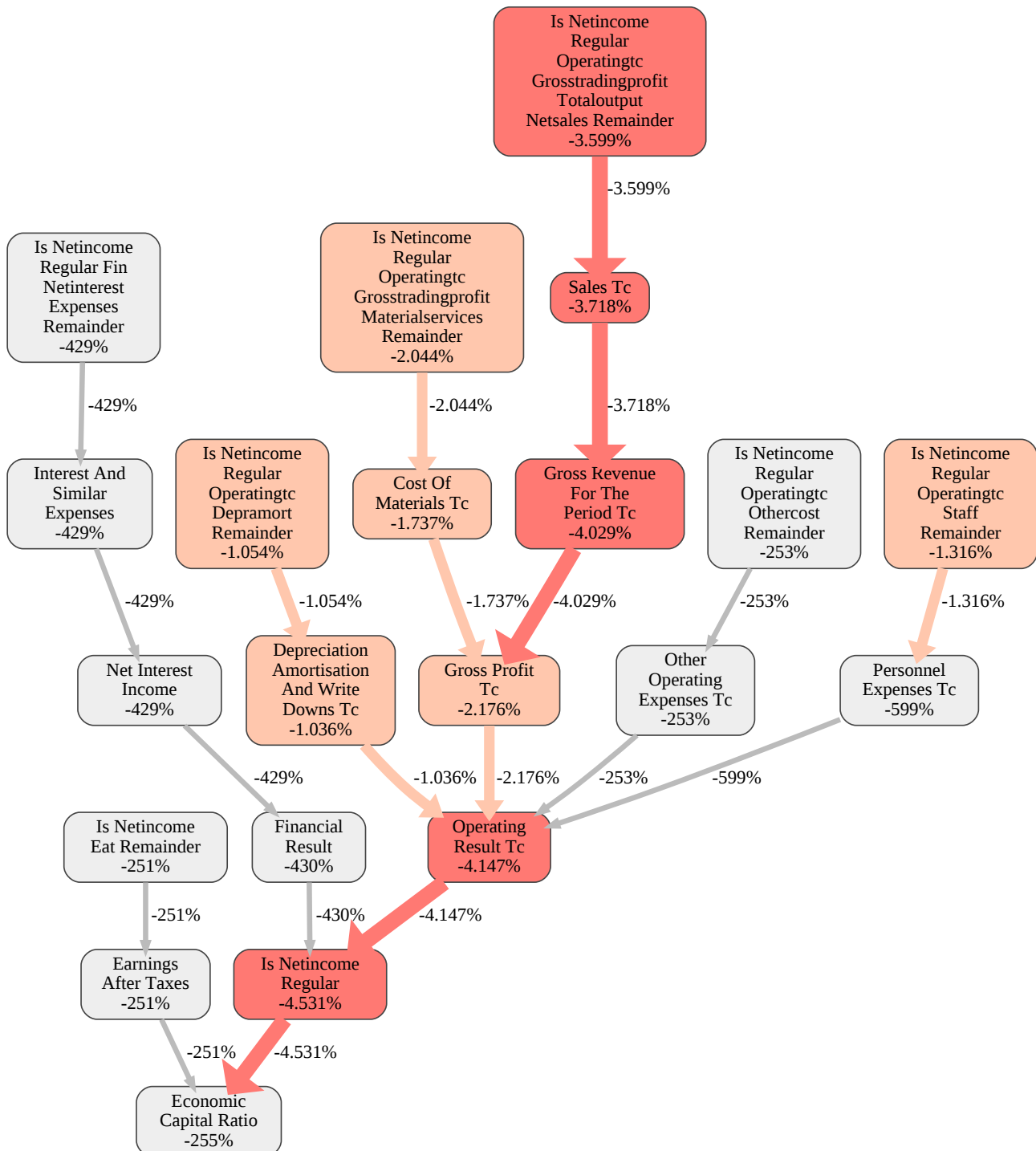




The relative strengths and weaknesses of Rensch GmbH Co Grundstücksverwaltung KG Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch GmbH Co Grundstücksverwaltung KG Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 106% points. The greatest weakness of Rensch GmbH Co Grundstücksverwaltung KG Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.531% points.

The company's Economic Capital Ratio, given in the ranking table, is 106%, being 255% points below the market average of 361%.
