The greatest strength of W Hundhausen Bauunternehmung GmbH Konzern compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 136% points. The greatest weakness of W Hundhausen Bauunternehmung GmbH Konzern is the variable Is Netincome Regular, reducing the Economic Capital Ratio by 4.470% points.

The company's Economic Capital Ratio, given in the ranking table, is 136%, being 225% points below the market average of 361%.
