

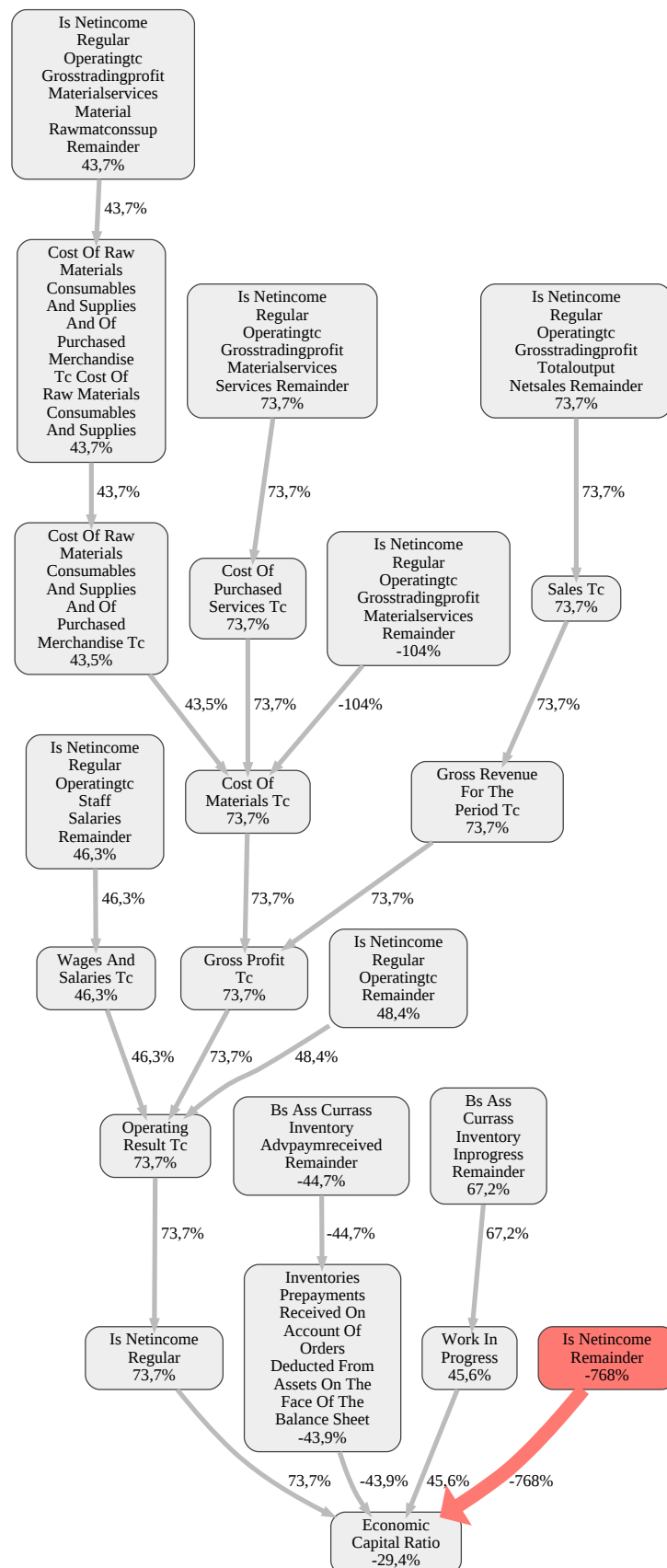

The greatest strength of Lambert Schlun GmbH Co KG compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 74% points. The greatest weakness of Lambert Schlun GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 768% points.

The company's Economic Capital Ratio, given in the ranking table, is 74%, being 29% points below the market average of 103%.
