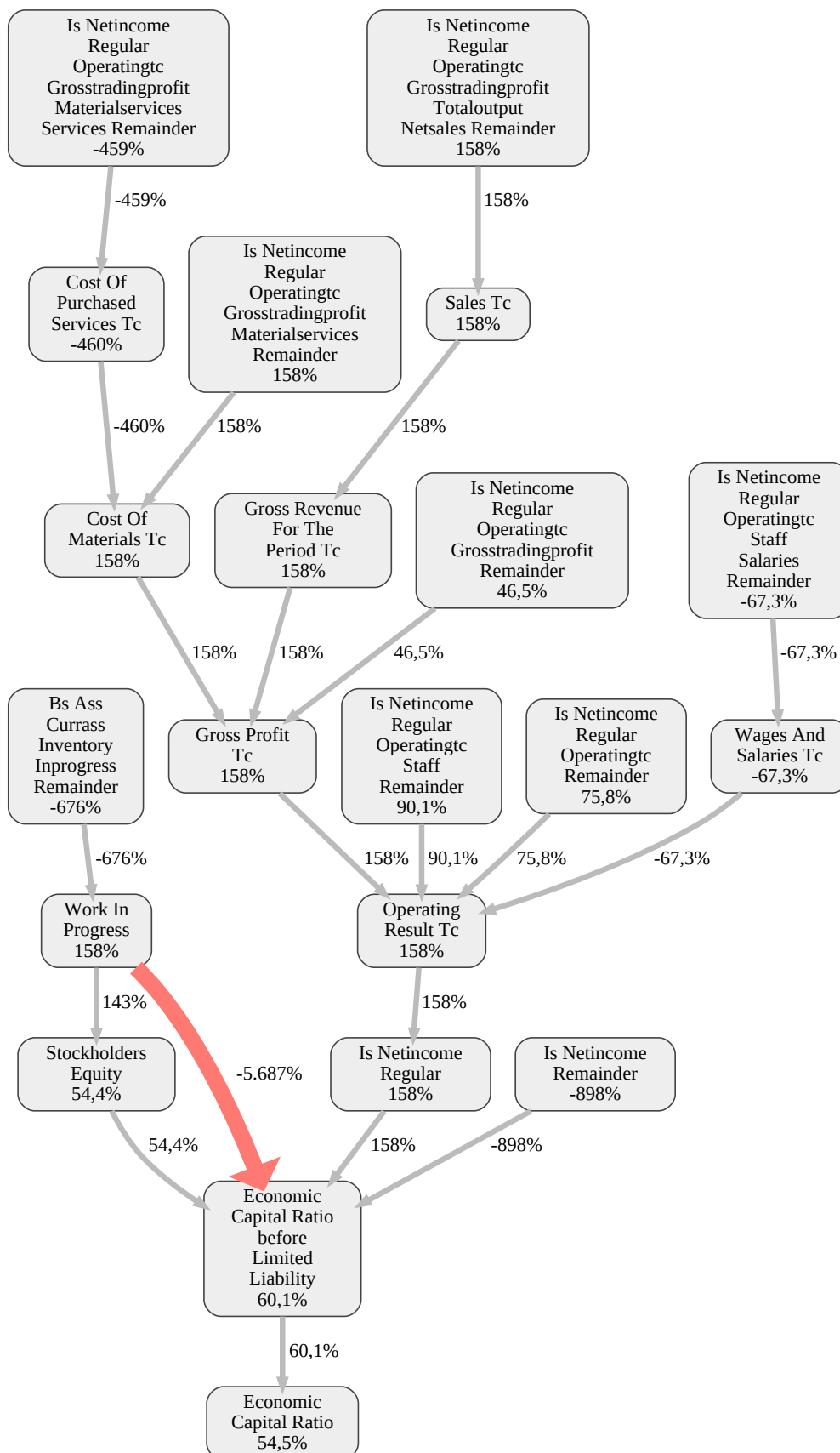




The relative strengths and weaknesses of Otto Wulff Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Otto Wulff Bauunternehmung GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 158% points. The greatest weakness of Otto Wulff Bauunternehmung GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 898% points.

The company's Economic Capital Ratio, given in the ranking table, is 158%, being 54% points above the market average of 103%.
