The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 535% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 8,3% points above the market average of 103%.
