The greatest strength of Xaver Lutzenberger GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Xaver Lutzenberger GmbH Co KG Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 265% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 0,31% points above the market average of 103%.
