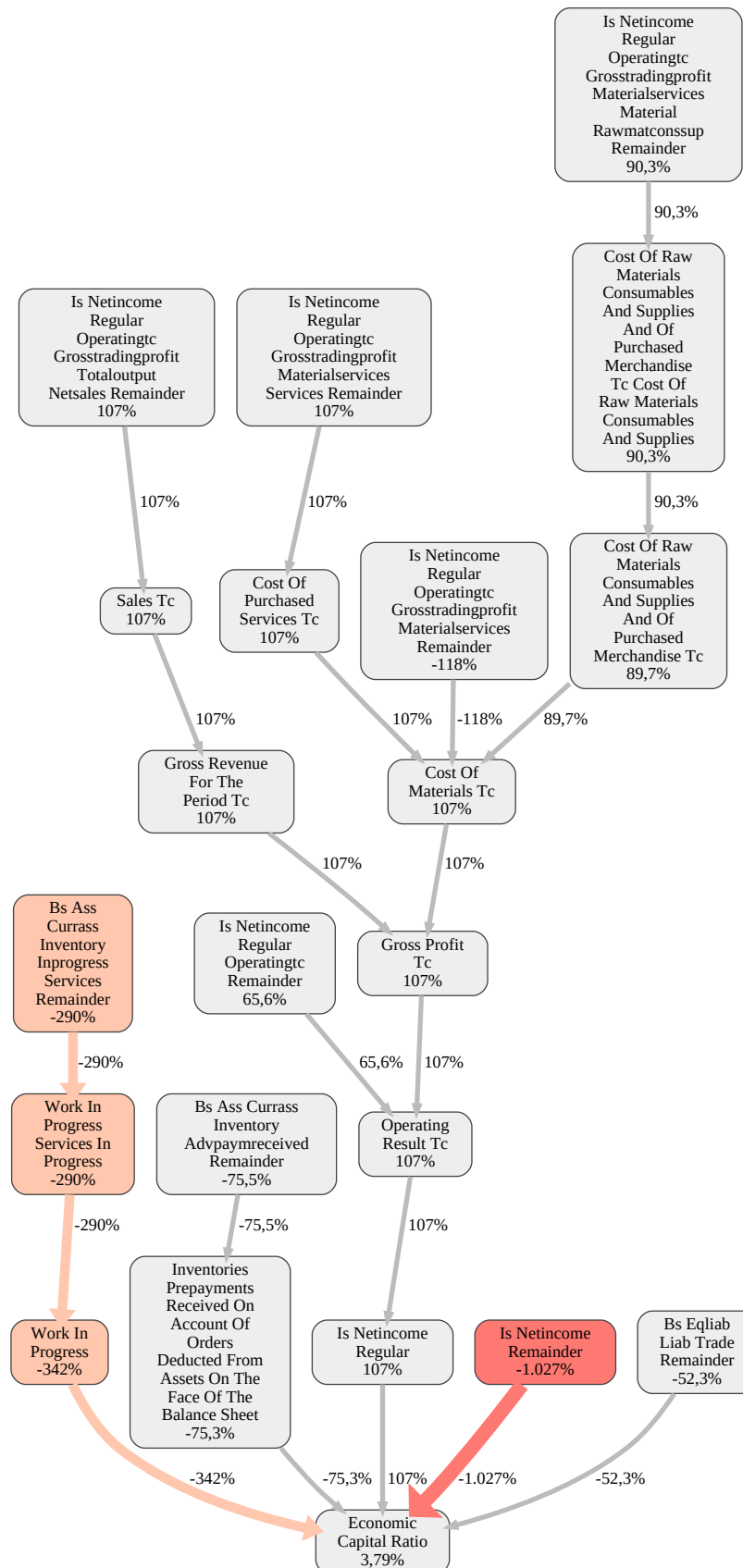

The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Totaloutput Netsales Remainder, increasing the Economic Capital Ratio by 107% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.027% points.

The company's Economic Capital Ratio, given in the ranking table, is 107%, being 3,8% points above the market average of 103%.
