The greatest strength of Josef Pfaffinger Bauunternehmung GmbH compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 155% points. The greatest weakness of Josef Pfaffinger Bauunternehmung GmbH is the variable Is Netincome Regular Remainder, reducing the Economic Capital Ratio by 986% points.

The company's Economic Capital Ratio, given in the ranking table, is 155%, being 52% points above the market average of 103%.
