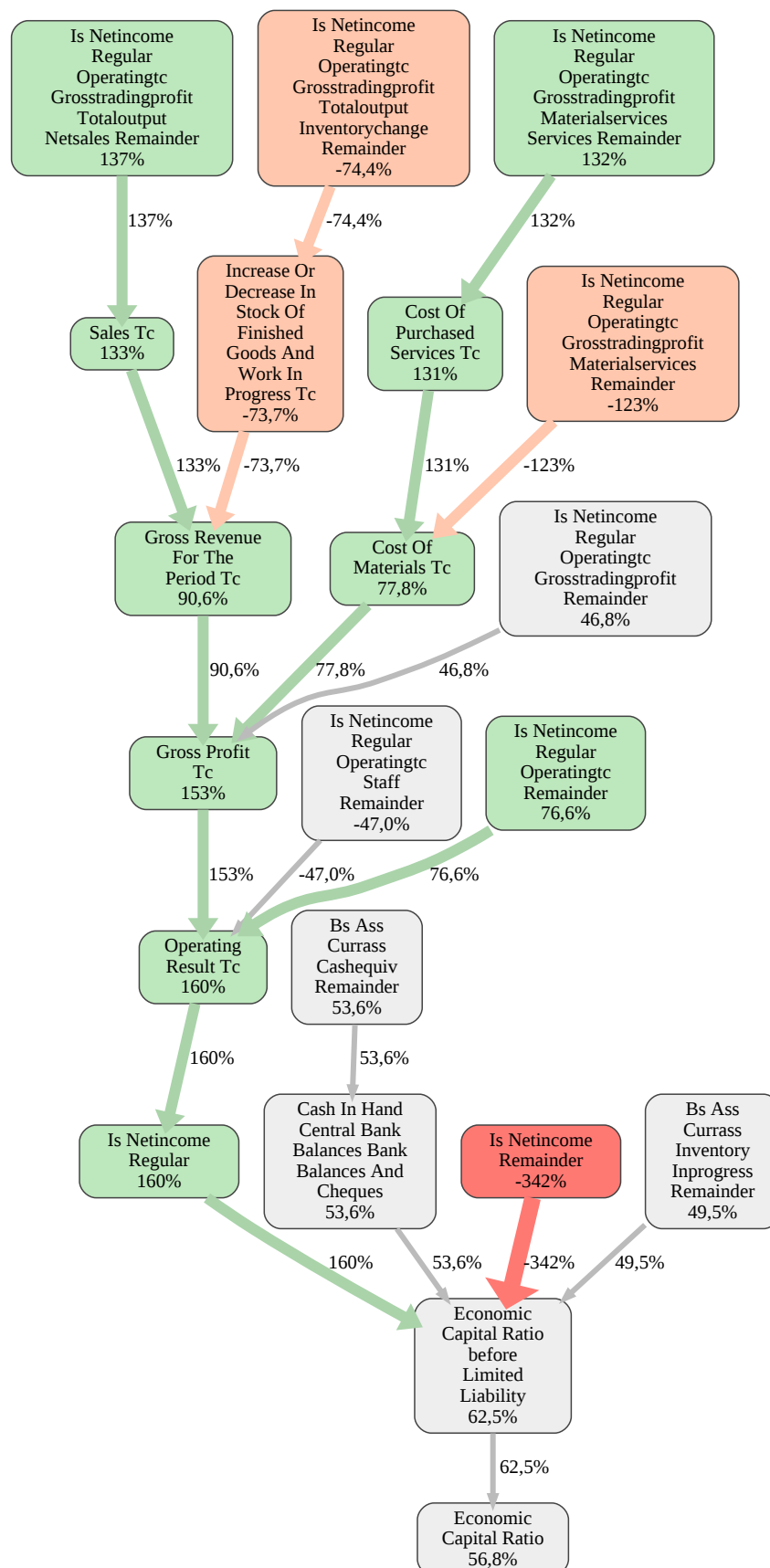




Finsterwalder Bau Union GmbH Sitz Zeckerin Rank 52 of 391

The relative strengths and weaknesses of Finsterwalder Bau Union GmbH Sitz Zeckerin are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Finsterwalder Bau Union GmbH Sitz Zeckerin compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 160% points. The greatest weakness of Finsterwalder Bau Union GmbH Sitz Zeckerin is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 342% points.

The company's Economic Capital Ratio, given in the ranking table, is 160%, being 57% points above the market average of 103%.
