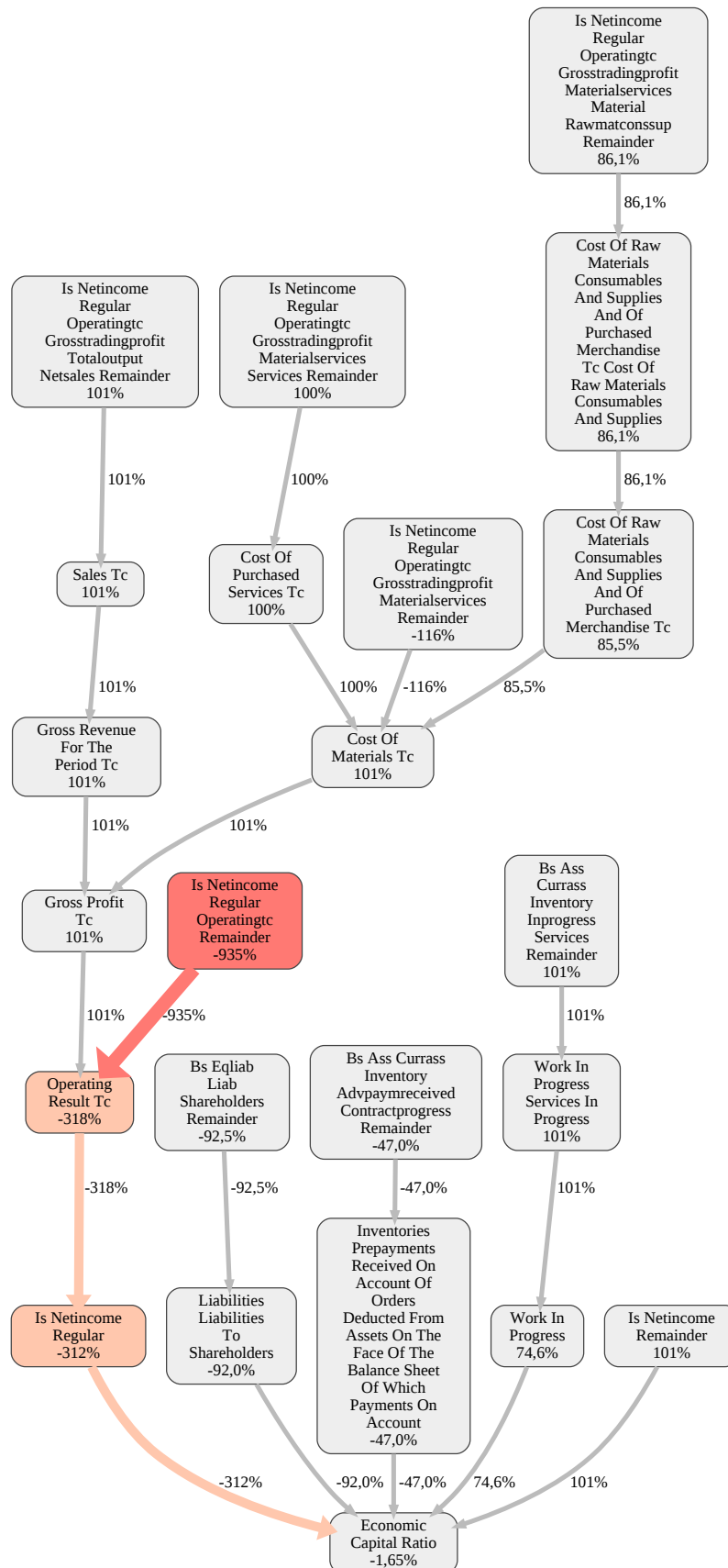

The greatest strength of Moser GmbH Co KG compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 101% points. The greatest weakness of Moser GmbH Co KG is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 935% points.

The company's Economic Capital Ratio, given in the ranking table, is 101%, being 1,6% points below the market average of 103%.
