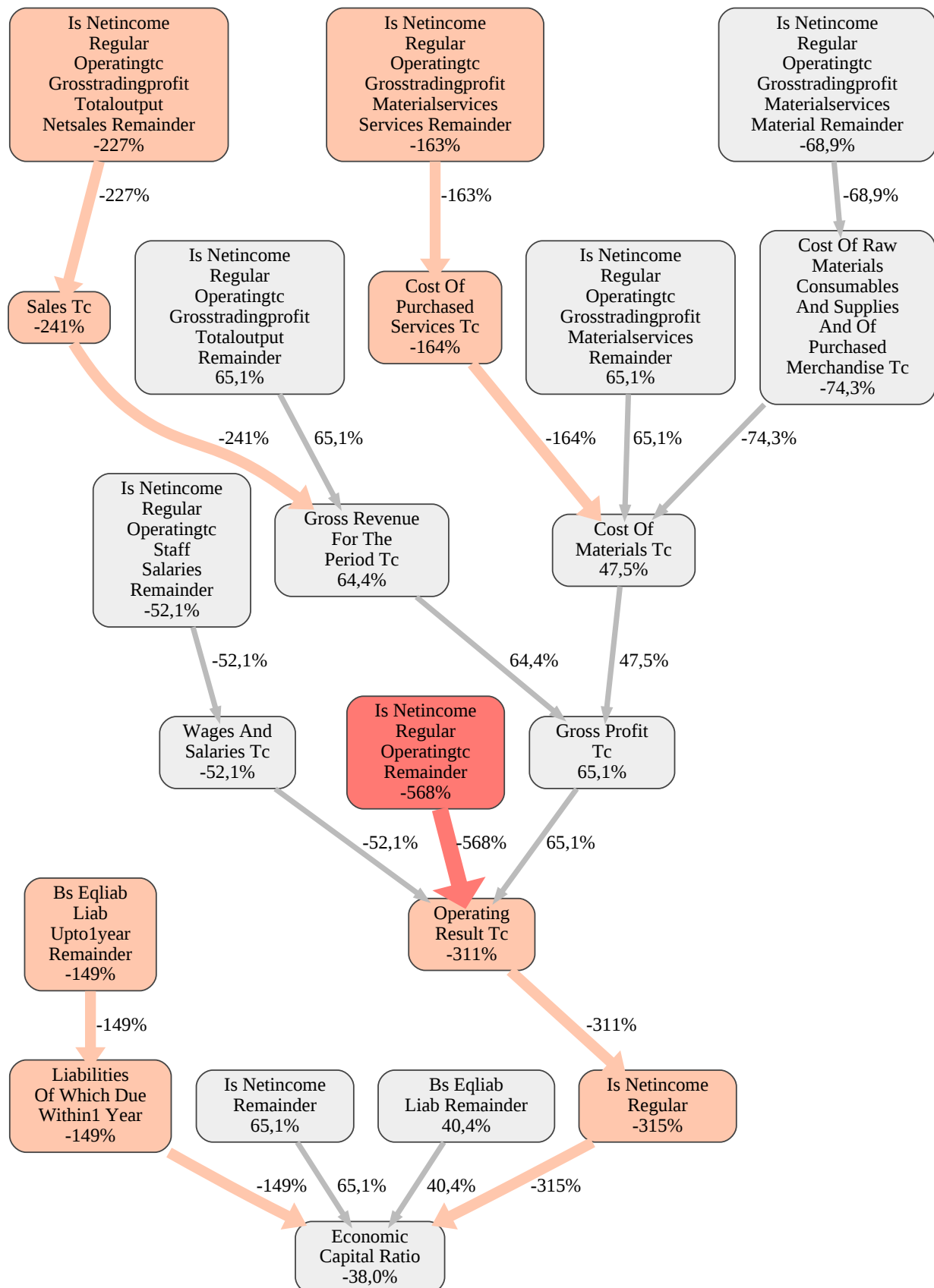

The relative strengths and weaknesses of Bien Zenker GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bien Zenker GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 65% points. The greatest weakness of Bien Zenker GmbH is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 568% points.

The company's Economic Capital Ratio, given in the ranking table, is 65%, being 38% points below the market average of 103%.
