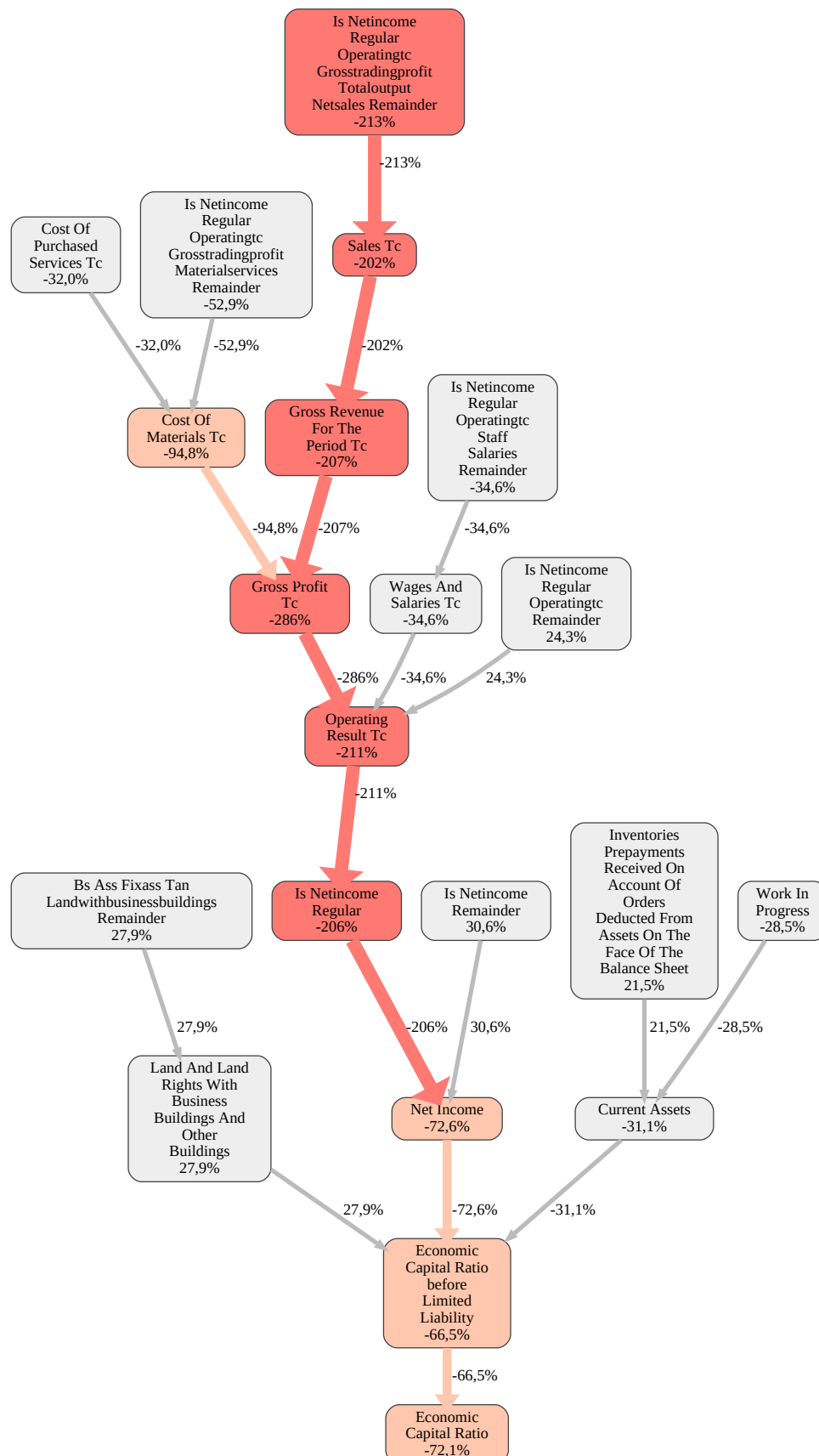




The relative strengths and weaknesses of Wohnbau Service Bonn GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnbau Service Bonn GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 31% points. The greatest weakness of Wohnbau Service Bonn GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 286% points.

The company's Economic Capital Ratio, given in the ranking table, is 31%, being 72% points below the market average of 103%.
