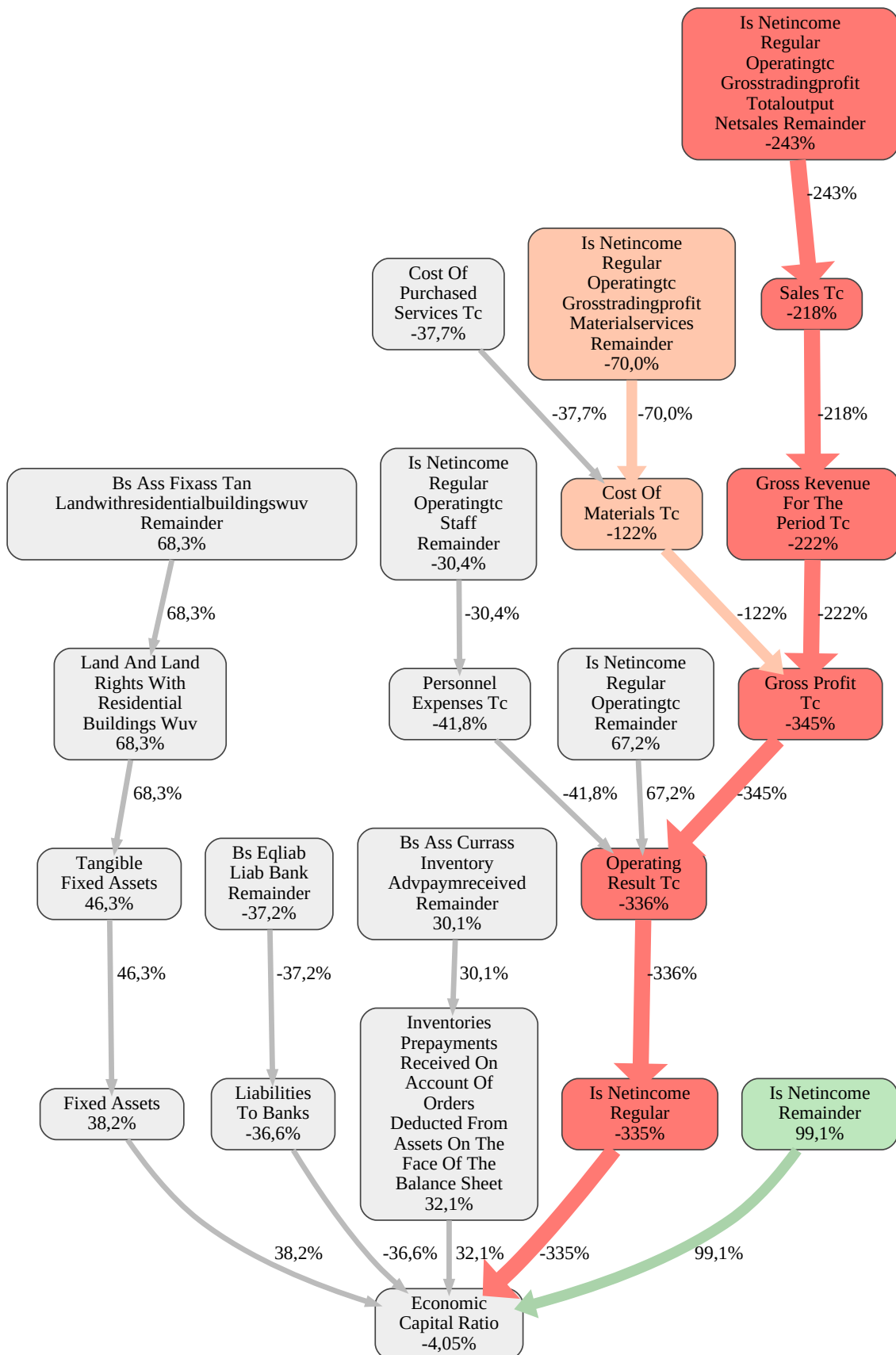




The relative strengths and weaknesses of Wohnungsbau GmbH der Stadt Schmalkalden are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wohnungsbau GmbH der Stadt Schmalkalden compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 99% points. The greatest weakness of Wohnungsbau GmbH der Stadt Schmalkalden is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 345% points.

The company's Economic Capital Ratio, given in the ranking table, is 99%, being 4,0% points below the market average of 103%.
