The greatest strength of Wohnungsbaugesellschaft mbH Meiningen compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Wohnungsbaugesellschaft mbH Meiningen is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 305% points.

The company's Economic Capital Ratio, given in the ranking table, is 82%, being 21% points below the market average of 103%.
