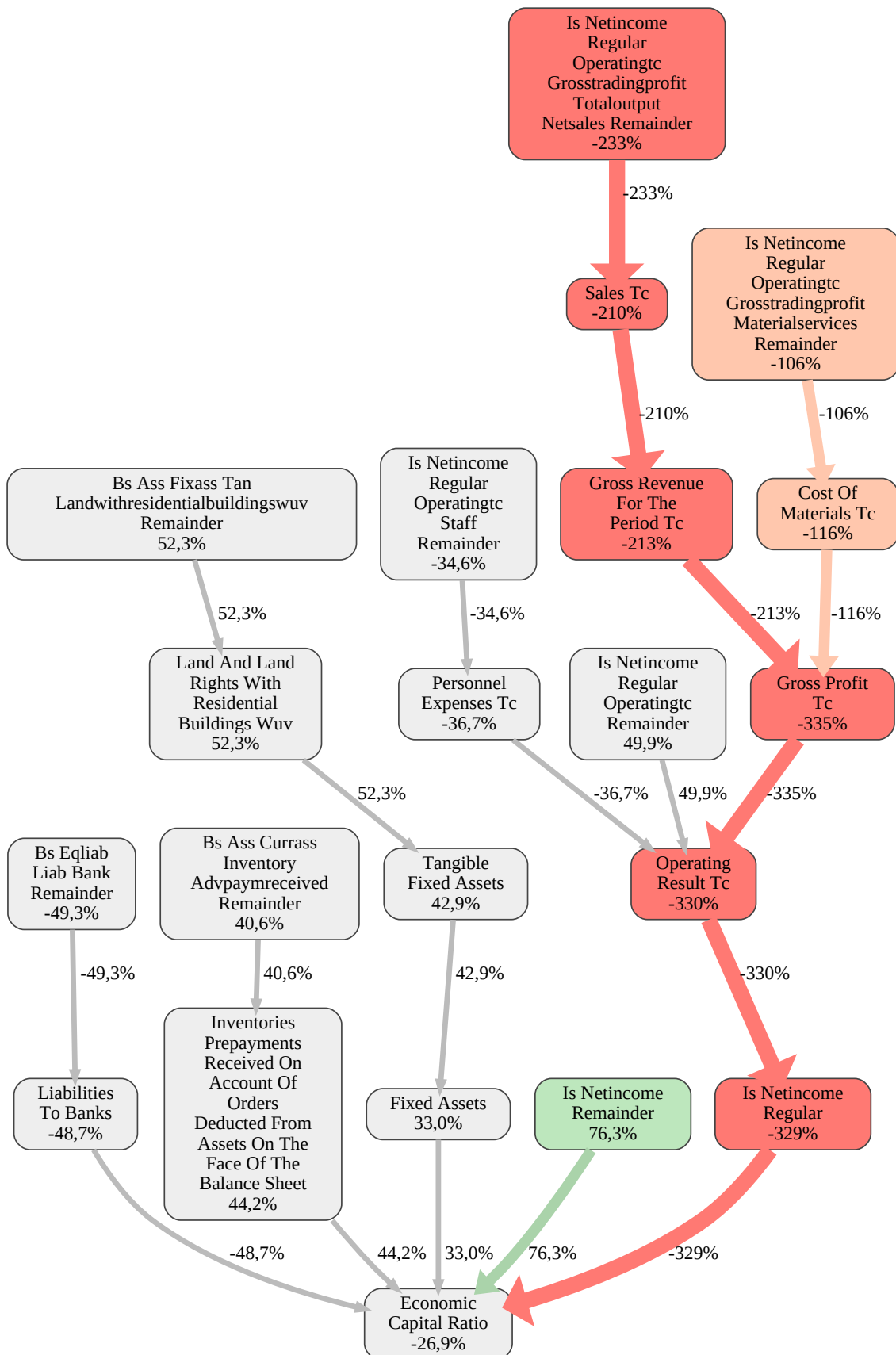




The relative strengths and weaknesses of HWG Hamelner Wohnungsbau Gesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of HWG Hamelner Wohnungsbau Gesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 76% points. The greatest weakness of HWG Hamelner Wohnungsbau Gesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 335% points.

The company's Economic Capital Ratio, given in the ranking table, is 76%, being 27% points below the market average of 103%.
