The greatest strength of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 103% points. The greatest weakness of Wohnungsbau Niedersachsen Gesellschaft mit Beschränkter Haftung is the variable Operating Result Tc, reducing the Economic Capital Ratio by 310% points.

The company's Economic Capital Ratio, given in the ranking table, is 103%, being 0,19% points below the market average of 103%.
