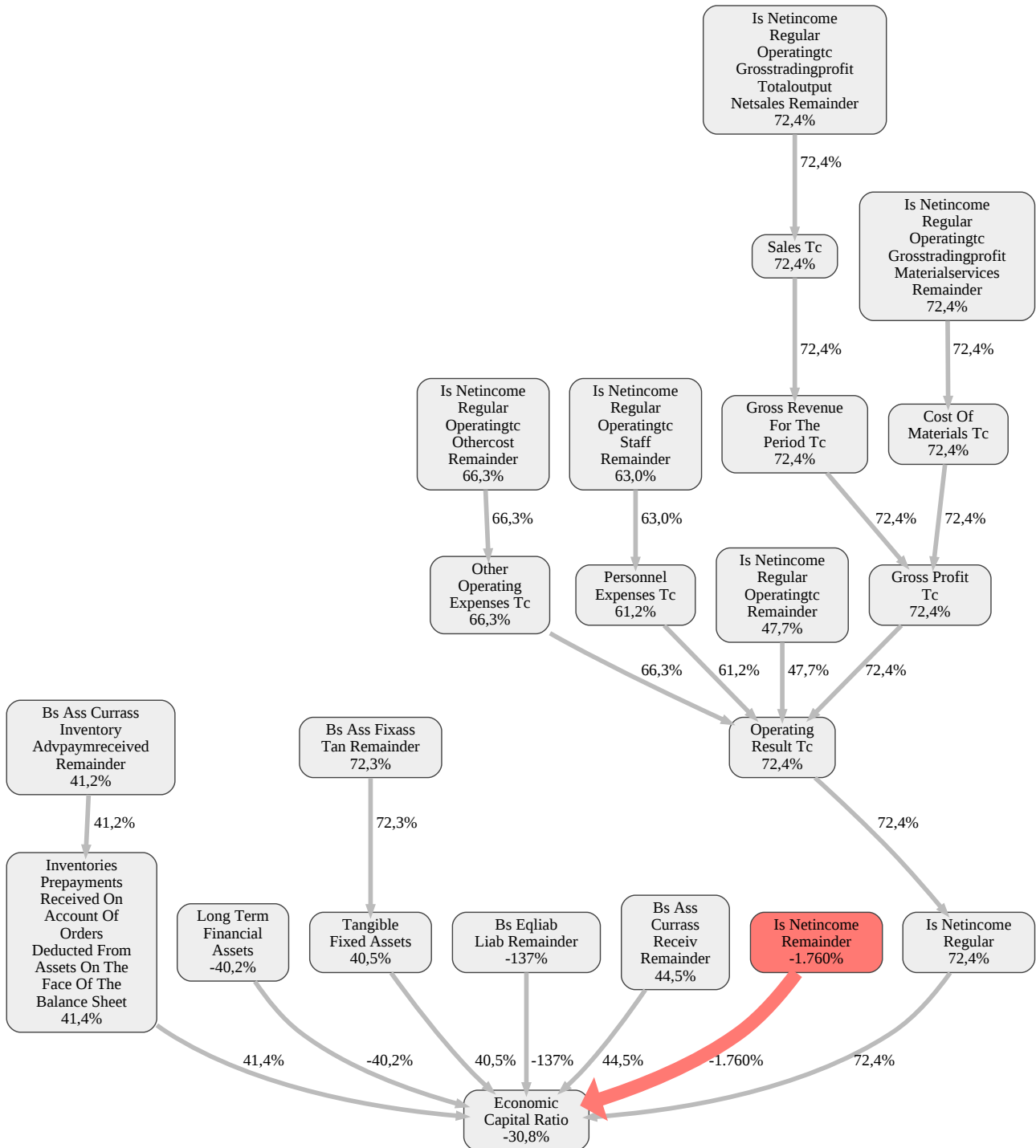

The greatest strength of H D Bau GmbH compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 72% points. The greatest weakness of H D Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 1.760% points.

The company's Economic Capital Ratio, given in the ranking table, is 72%, being 31% points below the market average of 103%.
