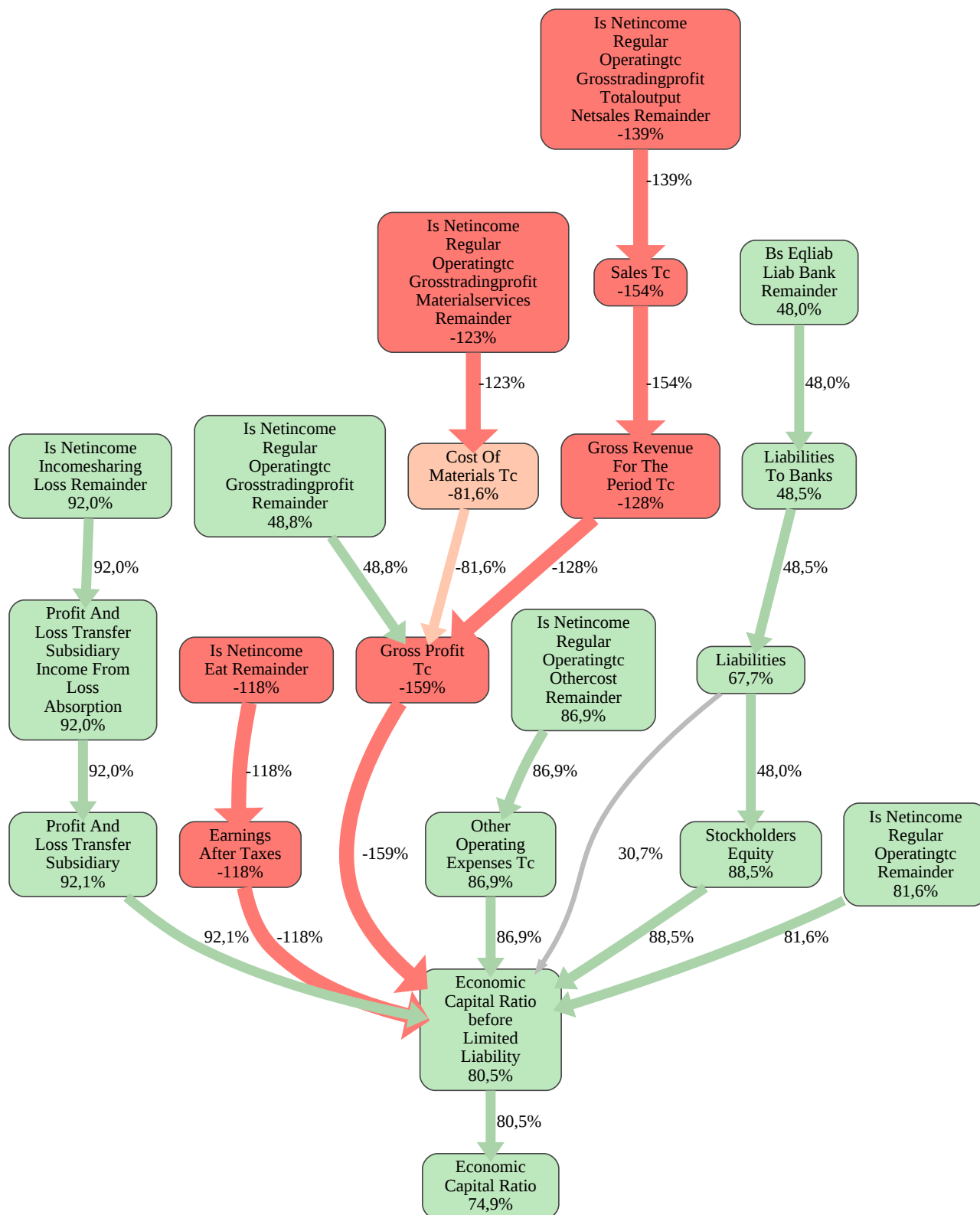




The relative strengths and weaknesses of Lindner Fassaden GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Lindner Fassaden GmbH compared to the market average is the variable Profit And Loss Transfer Subsidiary, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Lindner Fassaden GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 159% points.

The company's Economic Capital Ratio, given in the ranking table, is 178%, being 75% points above the market average of 103%.
