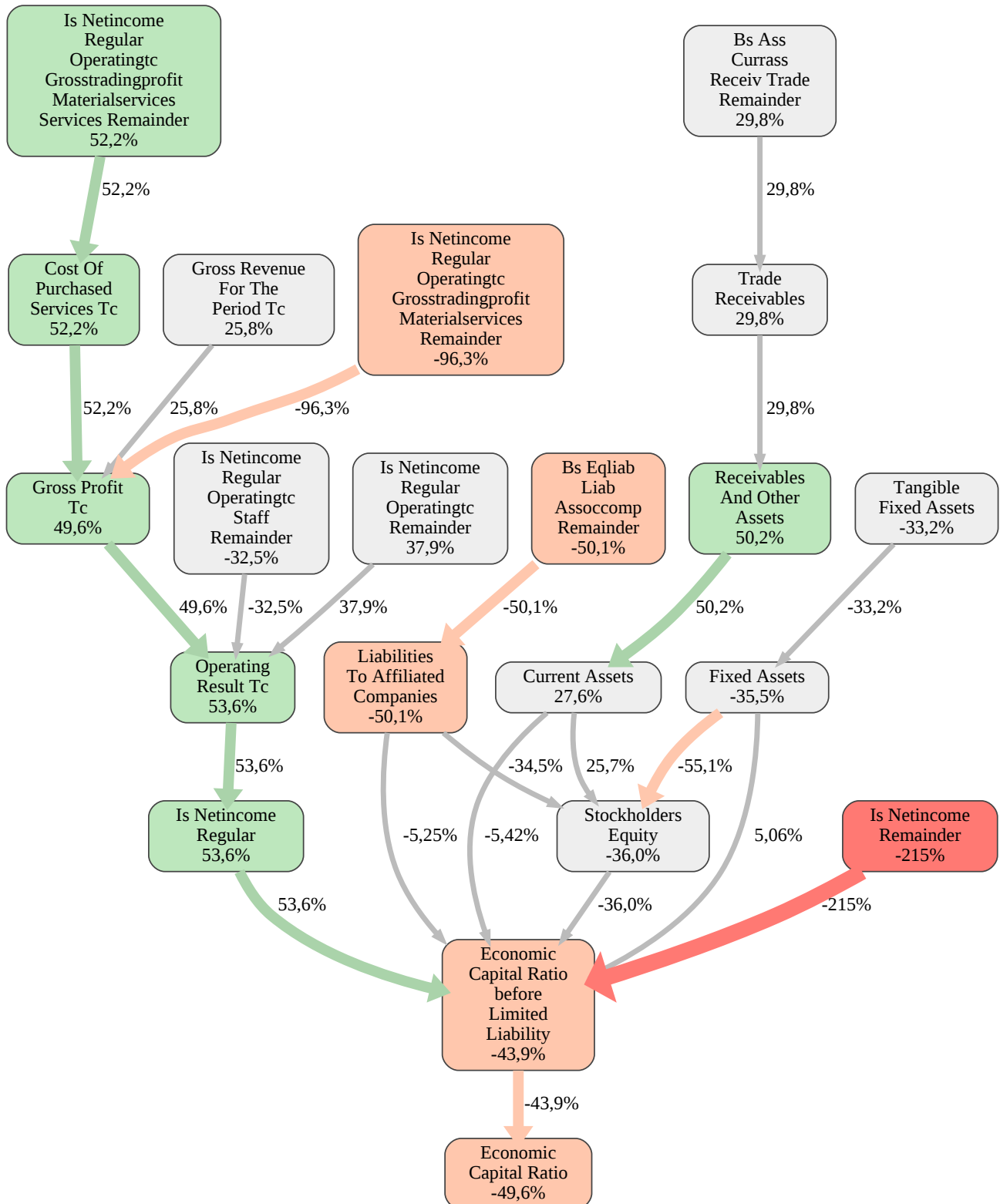

The greatest strength of d b Bau GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 54% points. The greatest weakness of d b Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 215% points.

The company's Economic Capital Ratio, given in the ranking table, is 54%, being 50% points below the market average of 103%.
