



The relative strengths and weaknesses of ELK Fertighaus GmbH Zweigniederlassung Dtl are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ELK Fertighaus GmbH Zweigniederlassung Dtl compared to the market average is the variable Gross Profit Tc, increasing the Economic Capital Ratio by 184% points. The greatest weakness of ELK Fertighaus GmbH Zweigniederlassung Dtl is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 1.099% points.

The company's Economic Capital Ratio, given in the ranking table, is 184%, being 81% points above the market average of 103%.
