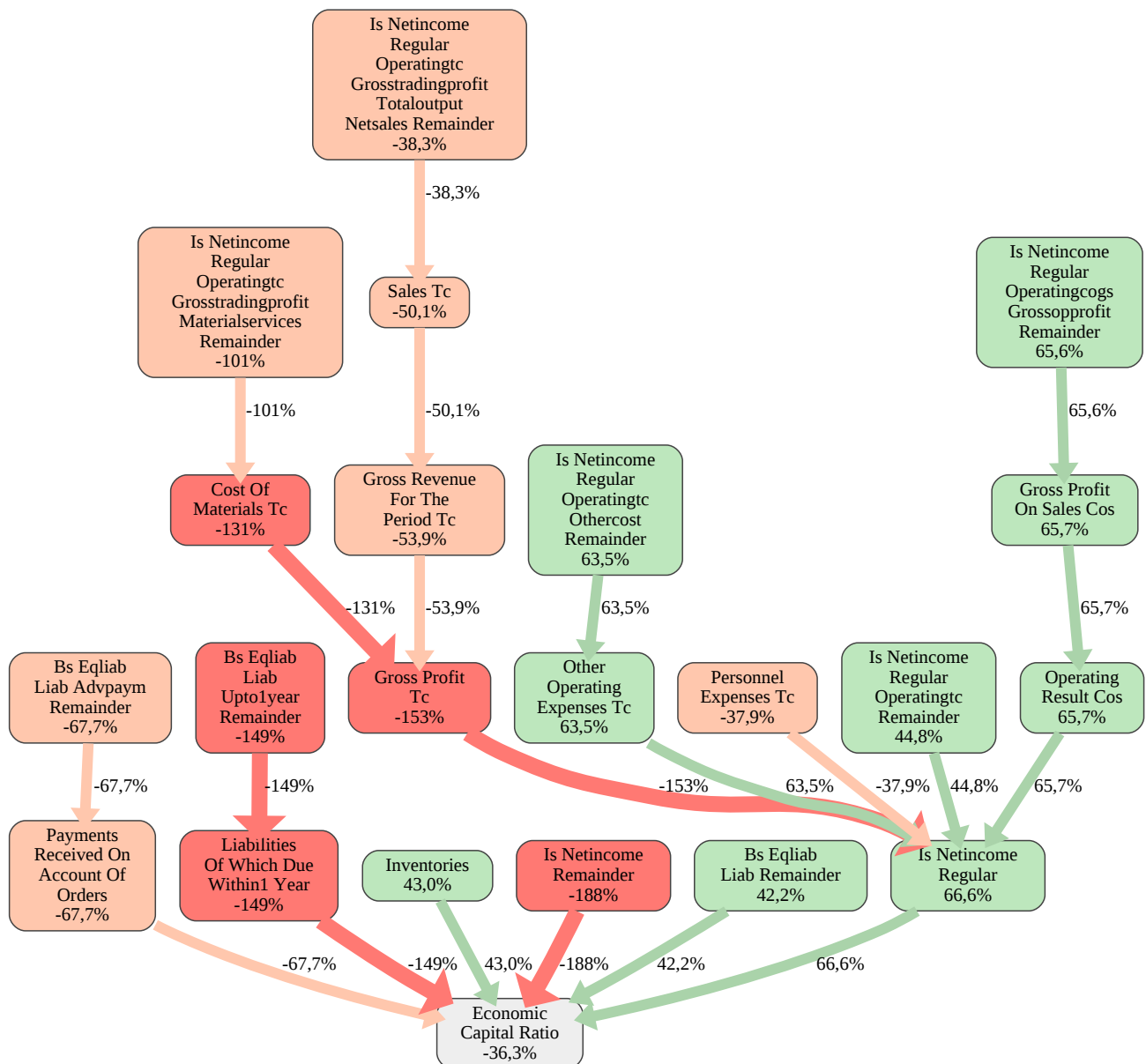

The relative strengths and weaknesses of Betocon GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Betocon GmbH compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 67% points. The greatest weakness of Betocon GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 188% points.

The company's Economic Capital Ratio, given in the ranking table, is 67%, being 36% points below the market average of 103%.
