The greatest strength of Josef Rädlinger Ingenieurbau GmbH compared to the market average is the variable Operating Result Tc, increasing the Economic Capital Ratio by 176% points. The greatest weakness of Josef Rädlinger Ingenieurbau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 603% points.

The company's Economic Capital Ratio, given in the ranking table, is 176%, being 73% points above the market average of 103%.
