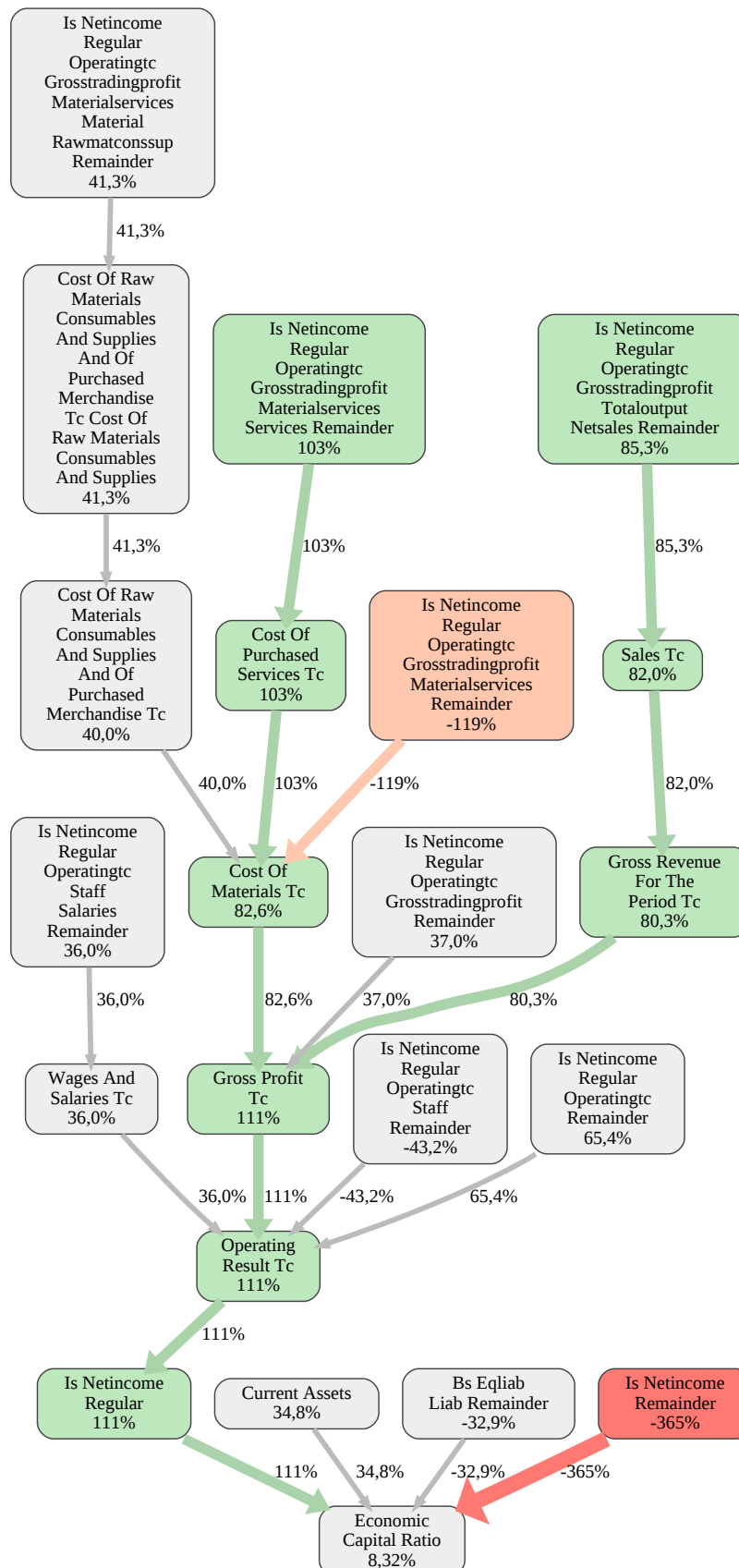




The relative strengths and weaknesses of August Prien Verwaltung GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of August Prien Verwaltung GmbH Konzern compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 111% points. The greatest weakness of August Prien Verwaltung GmbH Konzern is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 365% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 8,3% points above the market average of 103%.
