The greatest strength of Josef Hebel GmbH Co KG Bauunternehmung compared to the market average is the variable Is Netincome Regular Operatingtc Grosstradingprofit Materialservices Remainder, increasing the Economic Capital Ratio by 128% points. The greatest weakness of Josef Hebel GmbH Co KG Bauunternehmung is the variable Is Netincome Regular Operatingtc Remainder, reducing the Economic Capital Ratio by 635% points.

The company's Economic Capital Ratio, given in the ranking table, is 128%, being 24% points above the market average of 104%.
