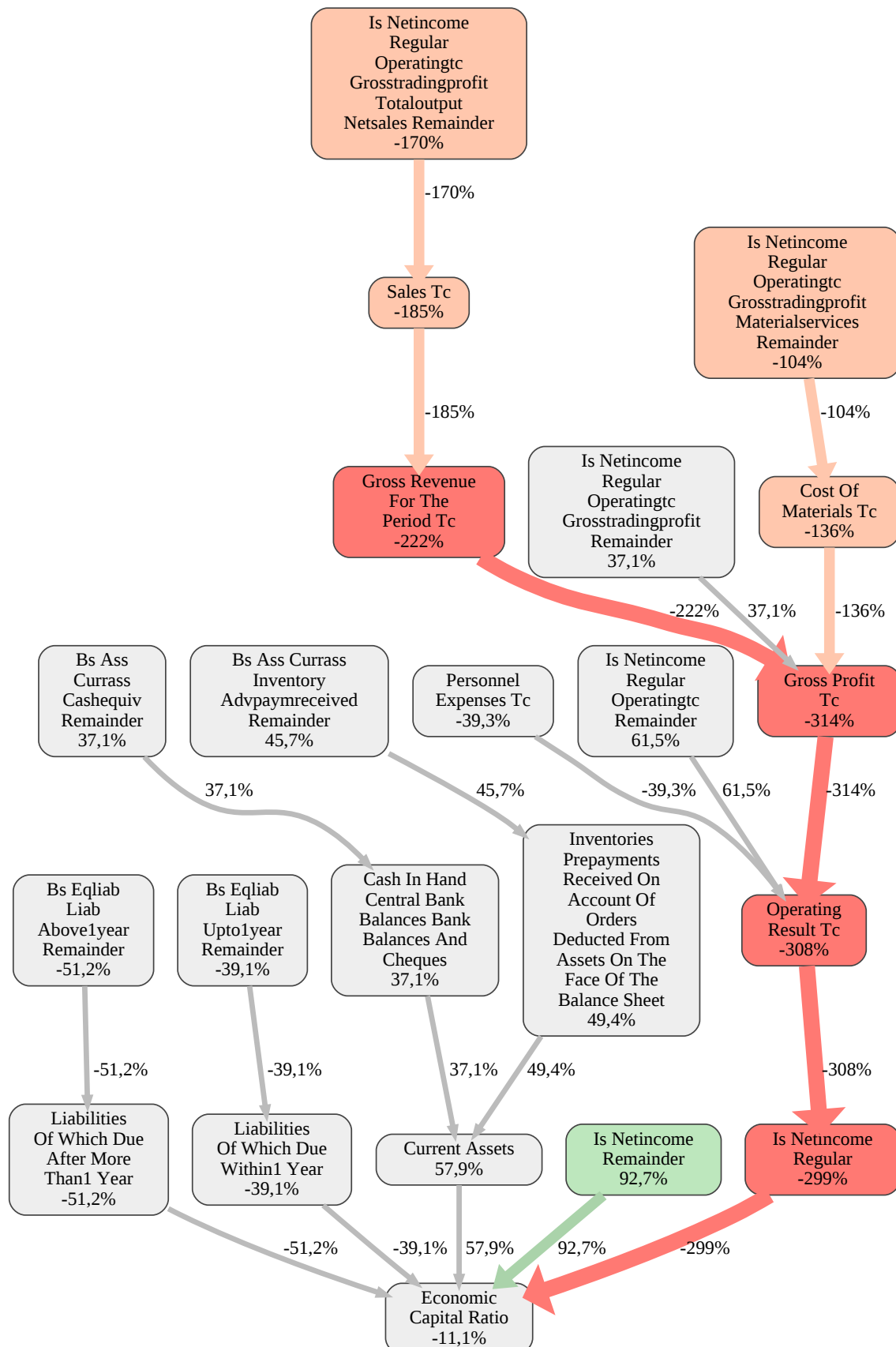

The relative strengths and weaknesses of Meier Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Meier Bau GmbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Meier Bau GmbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 314% points.

The company's Economic Capital Ratio, given in the ranking table, is 93%, being 11% points below the market average of 104%.
