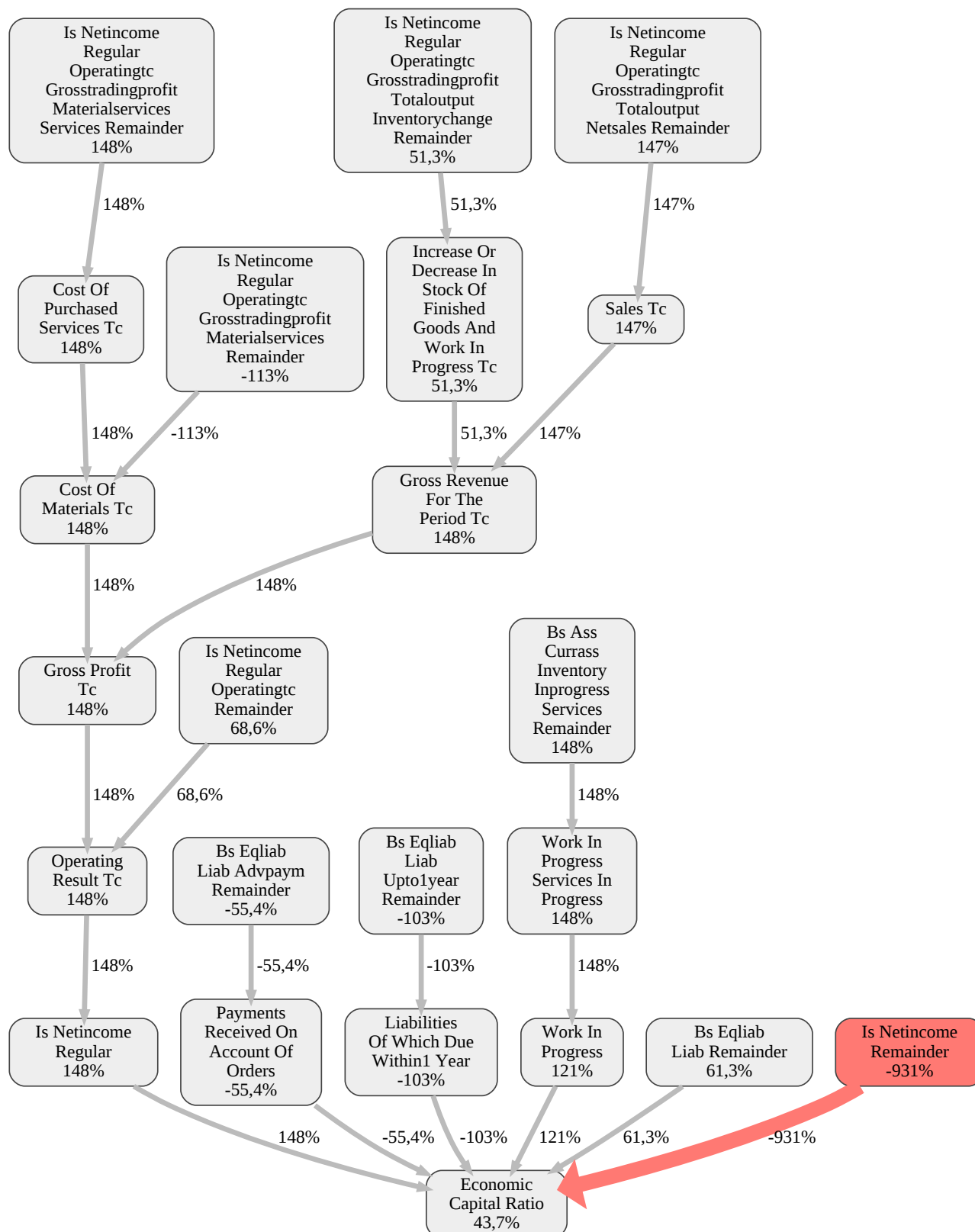




The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Bs Ass Currass Inventory Inprogress Services Remainder, increasing the Economic Capital Ratio by 148% points. The greatest weakness of Schmeing Bau GmbH is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 931% points.

The company's Economic Capital Ratio, given in the ranking table, is 148%, being 44% points above the market average of 104%.
