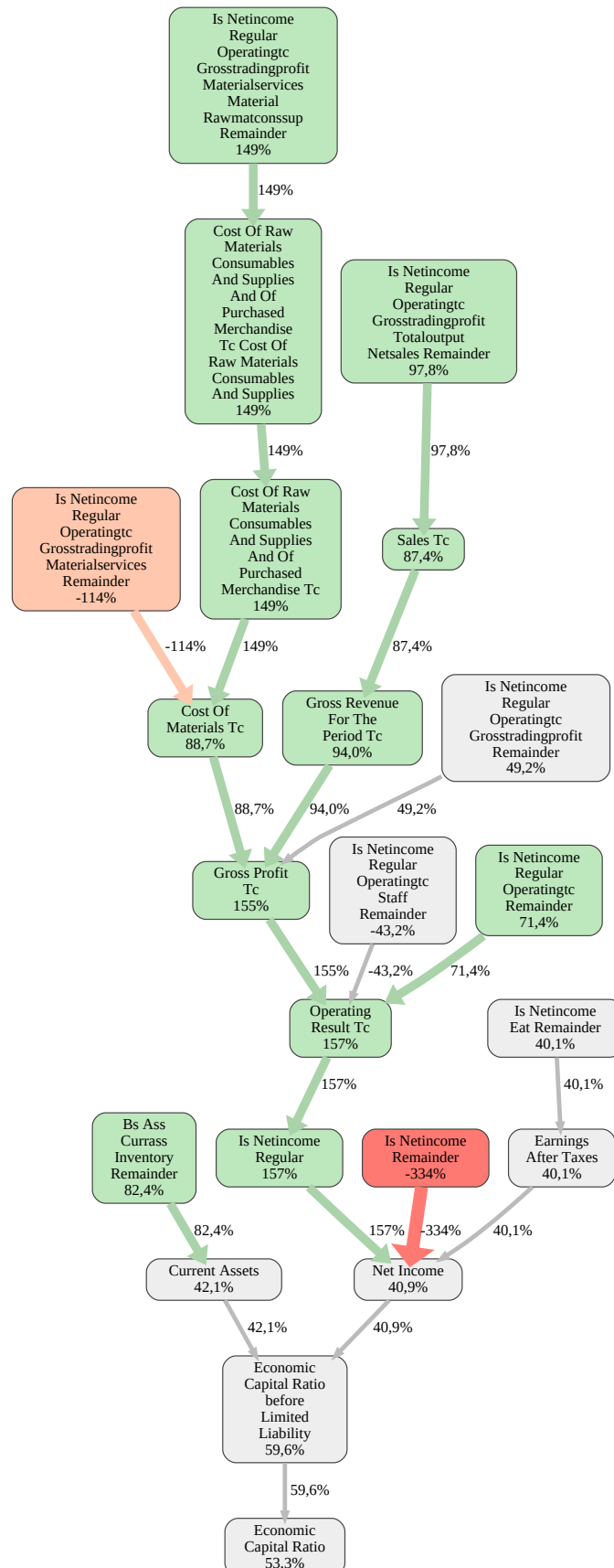




The relative strengths and weaknesses of Werner Wohnbau GmbH Co KG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Werner Wohnbau GmbH Co KG compared to the market average is the variable Is Netincome Regular, increasing the Economic Capital Ratio by 157% points. The greatest weakness of Werner Wohnbau GmbH Co KG is the variable Is Netincome Remainder, reducing the Economic Capital Ratio by 334% points.

The company's Economic Capital Ratio, given in the ranking table, is 157%, being 53% points above the market average of 104%.
