



The relative strengths and weaknesses of Degewo Köpenicker Wohnungsgesellschaft mbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Degewo Köpenicker Wohnungsgesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 47% points. The greatest weakness of Degewo Köpenicker Wohnungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 260% points.

The company's Economic Capital Ratio, given in the ranking table, is 47%, being 57% points below the market average of 104%.
