The greatest strength of Degewo Nord Wohnungsgesellschaft mbH compared to the market average is the variable Is Netincome Remainder, increasing the Economic Capital Ratio by 51% points. The greatest weakness of Degewo Nord Wohnungsgesellschaft mbH is the variable Gross Profit Tc, reducing the Economic Capital Ratio by 264% points.

The company's Economic Capital Ratio, given in the ranking table, is 51%, being 53% points below the market average of 104%.
